Dear Sir/Madam,

With reference to the above subject, we would like to inform you that the Company has submitted the Standalone and Consolidated Financial Results for the quarter ended December 31, 2024, along with the Auditor's Limited Review Reports, in compliance with Regulation 33 of SEBI (Listing Obligations and Disclosure Requirements) Regulations, 2015. Further, in response to your email dated February 19, 2025, regarding discrepancies in the XBRL submission of standalone financial results, please find our clarification below:

NSE Query	Company Response
Total tax and profit after tax not matching in PDF and XBRL of Standalone results	We observed that there was an inadvertent typographical error in the current tax figure in the XBRL submission, where it was incorrectly mentioned as "10.890" instead of "11.020". This typographical error also impacted the total tax, profit after tax, and other corresponding figures in the XBRL submission of the standalone financial results for the quarter ended December 31, 2024.


Additionally, we identified certain **casting errors/rounding-off differences in both the XBRL submission and the PDF of the financial results submitted for the quarter and nine months ended December 31, 2024**. These discrepancies will be rectified while filing the **revised XBRL submission for the financial results (both consolidated and standalone) for the quarter and nine months ended December 31, 2024**.

We would like to confirm that the **signed PDF copies of the Standalone and Consolidated Financial Results, as approved by the Audit Committee and the Board of Directors on January 23, 2025, and submitted to stock exchanges are accurate and correct**. The discrepancies identified were limited to the XBRL submission and were purely inadvertent and unintentional.

We request you to kindly take the above clarification on record.
