Tiger Logistics Strengthens its Presence in Western India as Solar EXIM Demand Accelerates

New Delhi, India – February 23, 2025 – Tiger Logistics, a leading international logistics company in India, has announced a strategic expansion of its Western India operations, deepening its presence in Gujarat, one of the company’s strongest growth markets for Solar EXIM (Export-Import).

Gujarat remains a critical node in the solar supply chain, accounting for **47% of India’s module manufacturing capacity** and **49% of cell production**. With existing branches in Gandhidham and Ahmedabad, Tiger Logistics has strengthened its position within this high-volume corridor with the **appointment of a General Manager – Gujarat Region** to reinforce operational discipline, enhance customer proximity, and accelerate on-ground responsiveness across key accounts.

Tiger Logistics’ renewable vertical, **TiGreen**, currently handles **up to 2,000 TEUs of solar container movements per month**, with the **majority of this volume coming from clients in the Gujarat region**. This anticipated opportunity is aligned with central schemes such as the **Pradhan Mantri Surya Ghar Muft Bijli Yojana**, which has renewed nationwide interest in rooftop adoption and is expected to generate substantial long-term component demand and EXIM flows.
