We further would like to inform you that all equity shares of JB Chemicals that were to be acquired by the Company under the Share Purchase Agreement dated 29th June, 2025 executed between the Company, Tau Investment Holdings Pte Limited and JB Chemicals as well as under the share purchase agreement dated 3rd July, 2025 executed between the Company and certain employees of JB Chemicals, have been acquired.

Following the aforesaid acquisition, the Company holds an aggregate of 7,83,57,892 equity shares of JB Chemicals, representing 48.80% of the equity share capital of JB Chemicals on a fully diluted basis.
