"Conversion of 3,48,000 warrants into equal number of equity shares of the Company"

Dear Sir/Madam,

In furtherance to our communication dated February 12, 2025 w.r.t. to allotment of warrants, in terms of Regulation 30 of the SEBI (Listing Obligations and Disclosure Requirements) Regulations, 2015, we wish to inform you that the fund-raising committee of the Company in their meeting held today i.e. Wednesday, May 13, 2026, *inter-alia*, considered and approved the allotment of equity shares on conversion of 3,48,000 warrants into 3,48,000 equity shares of face value of Rs. 10/- each at an issue price of Rs. 80/- each (including a premium of Rs. 70/- per share), to "Non-Promoters/Public Category", on preferential basis, upon receipt of balance amount aggregating to Rs. 2,08,80,000/- at the rate of Rs. 60/- (Rupees Sixty Only) per warrant (being 75% of the issue price per warrant) from the following allottees pursuant to the exercise of their rights of conversion into equity shares in accordance with the provisions of SEBI (ICDR) Regulations, 2018.
