- 4 As per MCA Notification dated 16th February, 2015 Companies whose Shares are listed on SME exchange as referred to in Chapter XB of SEBI (Issue of Capital and Disclosure Requirements) Regulation, 2009, are exempted from the compulsory requirement of adoption of IND-AS.
- 5 Earning per Equity Share (EPS) is calculated on the weighted average of share capital received by the company.
- 6 The Company is not having any subsidiary or holding company.
- 7 Pursuant to the approval of the shareholders at the Annual General Meeting held on 29th September, 2025, 9,60,000 equity shares of Rs.10/- each at a premium of Rs. 7/- have been issued on a preferential basis to the promoter group. Subsequent to the said approval, the Company has received in-principle approval from NSE and has completed the allotment of these shares on 31st October, 2025 in favour of the following members of the promoter group: Mr. M. C. Pandey, Ms. S. M. Pandey and Mr. N. M. Pandey.
