Further to our disclosure bearing Ref No: SSSL/08/2025-2026 dated 02nd May 2024, and pursuant to Regulation 30 of the SEBI (Listing Obligations and Disclosure Requirements) Regulations, 2015 read with Para A of Part A of Schedule III and read with the SEBI Master Circular No. SEBI/HO/CFD/PoD2/CIR/P/2023/120 dated July 11, 2023, we wish to report that, a warrant of release in admiralty in rem was issued by the Hon'ble High Court of Judicature of Tamil Nadu at Chennai (Madras) on 02nd May 2025 wherein, the vessel SSL Sabarimalai is vacated and she is permitted to sail immediately.

An invoice issued by the said M/s. Torque Technics (Plaintiff) for ship repair services availed by the Company for its vessel SSL Sabarimalai remained unpaid on account of it being sent to a dormant e-mail address of the Officials of the Company and hence the plea for arrest of vessel SSL Sabarimalai was filed with Hon'ble High Court of Judicature of Tamil Nadu at Chennai (Madras).
