Sub: Intimation under Regulation 30 of SEBI (Listing Obligations and Disclosure Requirements) Regulations, 2015 (“SEBI Listing Regulations”) - To update regarding a development in an ongoing litigation involving the Company and order passed thereto.

Ref: Prospectus dated July 10, 2025 (“Prospectus”).

As an update to our earlier disclosure in the Prospectus with respect to application filed by Airport Authority of India under Section 34 of the Arbitration and Conciliation Act, 1996 (“**Petition**”), challenging the arbitral award dated September 26, 2022 passed in favour of the Company by the sole arbitrator appointed under the arbitration proceedings initiated by our Company in 2018 in relation to its operations at the Dabolim Airport, Panaji, Goa, this is to further inform that, the Company has received an order dated April 6, 2026 (received by the Company on April 12, 2026), passed by Hon’ble High Court of Delhi (“**Order**”), whereby the Petition has been allowed by the Hon’ble High Court.

The Company is currently assessing the implications of the Order in consultation with its legal advisors and evaluating the appropriate course of action to safeguard the interests of the Company.

Further details as required under Clause 8 of Para B of Part A of Schedule III of the SEBI Listing Regulations, read with SEBI master circular no. HO/49/14/14(7)2025-CFD-POD2/1/3762/2026 dated January 30, 2026 (the “**SEBI Master Circular**”), are provided in **Annexure I** enclosed herewith.

2	Nature and details of change in the status and / or any development in relation to such proceedings	<p>Order dated April 6, 2026 (“Order”) (received by the Company on April 12, 2026) has been passed by Hon'ble High Court of Delhi, setting aside the arbitral award issued in favor of the Company dated September 26, 2022 (“Arbitral Award”).</p> <p><u>Brief Facts:</u></p> <p>The Company had initiated arbitration proceedings against Airport Authority of India, Goa Airport (Goa) (“AAI”) in relation to the F&B Concession at Goa Airport, seeking rebate in concession fee due to non-provision of electricity by AAI, along with release of security deposit, bank guarantee and other cash deposits with AAI. AAI, in turn, had raised its counterclaims pertaining to alleged non-payment of concession fee.</p> <p>An arbitral award dated September 26, 2022 was passed wherein certain amounts were awarded in favour of the Company and AAI's counter claims were rejected (“Arbitral Award”).</p> <p>Aggrieved by the same, AAI filed the application under section 34, Arbitration and Conciliation Act, 1996, challenging the Arbitral Award wherein the present Order has been passed, thereby allowing the AAI's petition. Our Company also had filed an application for the execution in April 2024 (“Execution Application”) of the Arbitral Award.</p> <p>In terms of the said Order, without getting into the merits of the award and based on a recent judgement of Hon'ble Supreme Court, Hon'ble High Court held that the unilateral appointment of Arbitrator by AAI in the matter to be ‘void ab initio’, thereby rendering the arbitral award a ‘nullity’ in the eyes of law. Consequently, the Execution Application filed by the Company in relation to the said Arbitral Award has also been disposed as infructuous.</p>
