Pursuant to Regulation 30 read with Schedule III of SEBI Listing Regulations and in continuation of our earlier letter dated 20<sup>th</sup> December, 2025, we hereby inform you that, the Company has on May 27, 2026, received a rectification order dated May 21, 2026 from the Office of the Commissioner of CGST and Central Excise, Mumbai Central, Mumbai, demanding tax and penalty (“**Rectification Order**”), wherein substantial relief has been granted to the Company by way of significant reduction in the earlier tax demand and penalty amount.

Further information as required under Clause 20 of Para A of Part A of Schedule III of the SEBI Listing Regulations is enclosed in the **Annexure I**.

The Company is evaluating the said Rectification Order and believes that it has a strong case based on merits and is evaluating further legal remedies. The Company will take appropriate action in due course, including but not limited to filing an appeal against the said Rectification Order with the relevant authorities pursuant to applicable laws.
