2. The present appeal has been filed against the order dated October 14, 2021 whereby the application for waiver of the fine for the delay in appointment of a director has been rejected.

Having heard the learned counsel for the parties, we find that the controversy involved in the present appeal is squarely covered by a decision of this Tribunal in *Shekhawati Poly-Yarn Limited & Ors. vs National Stock Exchange of India Limited and Anr. in Appeal no. 432 of 2021 decided on July 18, 2022*.
4. For the reasons stated therein, the order dated October 14, 2021 is quashed. The appeal is allowed.
