Summary of proceedings of the 39th Annual General Meeting:

voting facility provided by NSDL with respect to the items to be transacted at the 39th AGM. Cut-off date for e-voting was Friday, September 19, 2025.

The e-voting period commenced from **September 27, 2025, at 9:00 A.M.** and ended on **September 29, 2025 at 5:00 P.M.**

In remote e-voting, the shareholders who had not voted through remote e-voting process, were eligible to vote through the e-voting facility provided during the AGM and those who had already voted through remote e-voting process were eligible to participate in the meeting, but he/she was not entitled to e-vote again in the AGM.

The Chairman further informed the members that Mrs. Seema Kolwadkar, a Practicing Company Secretary is the authorised representative of M/s Anmol Jha & Co., Practicing Company Secretaries, was appointed as the Scrutinizer to scrutinize the e-voting at the meeting and remote e-voting process in a fair and transparent manner.
