

संसद में हंगामा: विपक्ष के 8 संसद निलंबित

प्रधानमंत्री नरेंद्र मोदी आज राष्ट्रपति के अभिभाषण पर धन्यवाद प्रस्ताव पर चर्चा का जवाब देंगे

लोक सभा से आठ विपक्षी सदस्यों को मंगलवार दोपहर 'अनुचित व्यवहार' पर बजट सत्र के बाकी अवधि के लिए निलंबित किए जाने के बाद विपक्षी सूची ने संकेत दिया कि उनके संसद पर्व सेना प्रमुख जनरल एम एम नरवणे की अप्रकाशित 'संसरण' के मुद्दे को सत्र के बाकी समय में लगातार उठाते रहेंगे। प्रधानमंत्री नरेंद्र मोदी बुधवार को राष्ट्रपति के अभिभाषण पर धन्यवाद प्रस्ताव पर चर्चा का जवाब देंगे।

लोक सभा में मंगलवार को जब राष्ट्रपति के अभिभाषण पर धन्यवाद प्रस्ताव पर दोपहर 2 बजे दोपहर चार शुरू हुए, तो विपक्ष के नेता राहुल गांधी बोलने के लिए उठे और पूर्व सेना प्रमुख नरवणे के अप्रकाशित 'संसरण' का हंगामा देने वाले एक लेख को सांसारित किया। किसी दस्तावेज को सांसारित करने के लिए एक सदस्य को उसकी हस्ताक्षरित प्रति जमा करनी होती है, जिसमें यह पुष्टि की जाती है कि वह उनको जानकारी के अनुसार सही है।

सदन की अध्यक्षता कर रहे कृष्ण प्रसाद टेटेनी ने राहुल गांधी से इसे पटल पर रखने के लिए आगे और कहा, 'इम जीजी जांच करेंगे और जवाब देंगे।' संसदीय कार्य मंत्री किरण रीजीजू ने कहा कि अध्यक्ष ने इस मामले पर फैसला सुना दिया है। उसके बाद गांधी को बार-बार यह मुद्दा नहीं उठाना चाहिए। गांधी ने जोर देते हुए कहा कि वह विपक्ष के नेता है। इसलिए जब उन्हें बोलना होता है तो 'अनुमति' लेने की बात कही जाती है।

अध्यक्ष के बाद अन्य व्यापारियों के नाम पुकारे, फिर भी राहुल गांधी खड़े रहे। राहुल गांधी से एक जुटाता दिया हुए तीन विपक्षी सांसदोंने बोलने से इकाकर कर दिया जबकि भाजपा वे नेतृत्व वाले राजग के घटक तेतुगु देशम पार्टी (तेदेपा) के हरीश बालायोगी अपनी बात रखने के लिए उठे। इससे कांग्रेस और अन्य विपक्षी सांसद सदन के बोले में आ गए। इसमें से कुछ ने महासचिव की मेज पर चढ़ने की कोशिश की, कांग्रेस

फ़ाड़े और उन्हें अध्यक्ष पर फेंका। हंगामा शांत नहीं होने के कारण टेनेटी ने सदन की कार्यवाही 3 बजे तक के लिए स्थगित कर दी।

कई बार सदन स्थगित होने के बाद भी हंगामा जारी रहा। सदन की कार्यवाही 3 बजे जैसे ही दोबारा शुरू हुई, अध्यक्ष पद पर आसीन दिलीप सैकिया ने 8 सांसदों के नाम पुकारे, जिनमें कांग्रेस के सात और भारतीय कान्युनिस्ट पार्टी (मार्क्सवादी) का एक सदस्य शामिल था। संसदीय कार्य मंत्री किरण रीजीजू ने बजट सत्र की

शेष अवधि के लिए आठों सदस्यों को निलंबित करने की मांग करते हुए प्रस्ताव रखा। रीजीजू ने कहा कि सदस्यों ने सदन और अध्यक्ष के अधिकार की अवैलना की है। बजट सत्र 2 अप्रैल तक चलेगा। निलंबित होने वाले सदस्य गुरुजीत सिंह औजाला, हिंदी इंडन, सी किरण कुमार रेडी, अमरिंदर सिंह राजा वडिंग, मणिकम टौरेग, प्रसांत पड़ोले और डीन कुरियाकोस (सभी कांग्रेस) और एस वेंकटेशन (सीपीआई-एम) हैं। सदन ने ध्वनि मत से प्रस्ताव पारित

संसद भवन परिसर में राजग के सांसदों के साथ प्रधानमंत्री नरेंद्र मोदी करती है। राजग गठबंधन के सदस्यों ने सूर्योपीय संघ (ईयू) और अमेरिका के साथ व्यापार समझौते के लिए प्रधानमंत्री को बधाई दी और समानित किया। उन्होंने कहा कि इसके साथ मंत्री ने कांग्रेस की नियांतकों की बैठक को संबोधित करते हुए।

और उन्होंने को इस समझौते से मजबूती मिली। अमेरिकी द्वारा भारतीय वस्तुओं पर शुल्क लगाने के बाद राजनीतिक विवरणों के बदले विशेष रूप से भारतीय जनता पार्टी (भाजपा) शासित गुरुजत से थम गया था। इसके साथ ही तेलुगु देशम की आजीविका की रक्षा करता है।

राष्ट्रीय स्वयंसेवक संघ (आरएसएस) से सबल संगठनों, विशेष रूप से स्वदेशी जागरण मच (एसजेएम) और भारतीय किसान संघ ने सरकार से देश के किसानों पर इसके दुष्क्रियता के हितों को दाव पर नहीं लगाने के लिए कहा था। एसजेएम के सह-संयोजक अशिवनी महाजन ने इस समझौते का स्वागत किया व्यापक यह भारत के किसानों और उसके दुष्क्रियता की आजीविका की रक्षा करता है।

WhatsApp, Meta face SC heat over data sharing

The Supreme Court on Tuesday said it will not permit instant messaging platform WhatsApp and its parent company Meta to breach the right to privacy of millions of their "silent consumers" in India through the sharing and commercial exploitation of personal data.

At one point during the hearing, a three-judge Bench headed by Chief Justice of India Surya Kant, addressing Meta and WhatsApp, compared the sharing of private data to a "decent way of committing theft", saying by now "you must have taken away millions of bytes of data".

"OPT-OUT" OPTION WhatsApp and Meta, led by senior advocates Mukul Rohatgi and Amit Sibal, vehemently objected to the court's observations, maintaining that users could "opt out" from having their data shared.

They said prior consent was cardinal. WhatsApp stressed that messages sent and received on its platform were end-to-end encrypted.

Justice Joymalya Bagchi, who along with Justice Vipul M. Pancholi formed part of the Bench, pointed out that every silo of data regarding an individual, irrespective of whether it was private or not, had value.

The Chief Justice gave an example of a person communicating online with his doctor about medicines, only to get advertisements or notifications about medical services available minutes later.

Solicitor General Tushar Mehta, present in the court room, said, "Our private data is not only sold, but it is commercially exploited. We are

not only consumers, but also products." The Bench implored the Centre, through the Ministry of Electronics and Information Technology, as a party in the case.


The court was hearing petitions filed by Meta and WhatsApp against a National Company Law Appellate Tribunal (NCLAT) decision last year to uphold a ₹213.14 crore penalty imposed by Competition Commission of India.

The anti-competition regulator had found WhatsApp's 'take-it-or-leave-it' approach in its 2021 privacy policy an abuse of its market dominance. It found the prior consent sought from users to share their data with Meta "manufactured".

Rohatgi said users did have a choice to opt-out. "What 'opt out'? Then you opt out of the country," Chief Justice Kant retorted.

LEGAL IMPLICATIONS "We will examine everything from the perspective of a common consumer of this country. How many people will understand the legal implications you impose. Where is the question of 'opt out'? In actuality, there is no such option. By now you must have taken out millions of data. In a way, this is a decent way of committing theft in a way. We will not allow this to happen... You have to give an undertaking or we will impose very strict conditions," Chief Justice Kant told the online entities.

No faults in Air India's Boeing 787 fuel switches, say DGCA officials

Boeing recommended procedures for operation of the fuel control switch.

On its part, Air India is also re-inspecting the fuel control switches on all its 33 Boeing 787 planes. "Our engineers — out of abundance of caution — have initiated precautionary fleet-wide re-inspection of the fuel control switch latch to verify normal operations.

Fuel control switches manage fuel flow to engines and have been in focus following the Air India 171 accident in Ahmedabad last June.

UNDER SUPERVISION

In a note, DGCA said Air India engineers carried out checks on the aircraft under their officers' supervision. It said applying external force in an incorrect direction caused the switch to move easily from "run" to "cutoff" mode.

The DGCA has also advised Air India to circulate

the preliminary report on the Air India 171 crash released by the Aircraft Accident Investigation Bureau had highlighted the transitioning of the fuel cut off switch from "run" to "cutoff" mode, indicating cut in fuel supply to the engines.
