**Sub: Scrutinizer Report on e-Voting process conducted pursuant to the provisions of Section 108 and 110 of the Companies Act 2013 ('the Act') read with Rule 20 & 22 of the Companies (Management and Administration) Rules, 2014**

(1) The Board of Directors of **M/s. TTK HEALTHCARE LIMITED** have on March 21, 2025 appointed M/s. A.K. - (e) The members of the Company as on the "cut-off" date (i.e.) Friday, March 21, 2025, were entitled to vote on the resolution mentioned in the postal ballot notice through remote e-Voting platform provided by Central Depository Services Limited (CDSL).


