Pune, January 11, 2025- Tunwal E-Motors Limited (NSE: TUNWAL), India's leading E-Vehicle manufacturer, extends its deepest condolences to the customer, following the unfortunate fire incident. Our thoughts are with the affected family during this difficult time.

Sunday, 5th January 2025, at Ratlam, Madhya Pradesh

At Tunwal E-Motors, the safety of our customers is our highest priority, and we are dedicated to the quality and integrity of the products we deliver. Following a thorough investigation, we would like to clarify the circumstances surrounding it and assure the public that Tunwal E-Motors Limited is not culpable in this case.

The battery involved in the incident could not be confirmed as one of our company's products. We have discovered that the vehicle remained with the dealer until three days before the incident. Unfortunately, the dealer did not inform us of any changes, which hindered our ability to verify the battery's condition before the incident took place. Additionally, we have no details regarding any modifications the dealer may have made to the vehicle. The service engineers at the incident site clarified that the battery was left to charge overnight, leading to overheating. Furthermore, a petrol vehicle was parked near our electric vehicle, which escalated the fire.

We want to make it clear that Tunwal E-Motors Limited takes full responsibility for ensuring the safety and quality of our products. However, in this case, the issue arose due to the dealer's failure to adhere to proper procedures. The dealer did not inform us about the battery replacement or share the necessary documentation, which significantly hindered our ability to investigate and address the issue in a timely manner.
