Sub: Disclosure under Regulation 30 of SEBI (Listing Obligations and Disclosure Requirements) Regulations 2015 ('Listing Regulations') - "Receipt of Letter of Acceptance for Design, Manufacture, Supply, Testing and Commissioning of 62 Rail Borne Maintenance Vehicle (RBMV)"

Pursuant to Regulation 30 read with Schedule III of the Listing Regulations, we wish to inform you that the Company has received a Letter of Acceptance (LOA) dated 17th December, 2025 and secured its *first order under the Safety and Signalling Systems* from Indian Railways for the Design, Manufacture, Supply, Testing and Commissioning of Rail Borne Maintenance Vehicles (RBMV), including training of Indian Railways personnel and servicing and breakdown maintenance.

The RBMV is a specialised, self-propelled on-track maintenance machine engineered for efficient inspection, maintenance and restoration of railway infrastructure. The machine integrates advanced mechanised systems for track maintenance, overhead equipment (OHE) works, and allied activities, enabling enhanced operational safety, precision, reliability and asset availability across the rail network.

This maiden order marks a significant strategic milestone for TRSL, signalling the Company's successful entry into a high-value, technology-driven and safety-critical segment. The order aligns with Indian Railways' focus on mechanisation, safety enhancement and modernisation of maintenance practices, and reinforces TRSL's expanding capabilities beyond rolling stock manufacturing into integrated rail safety and maintenance solutions.

The order is valued at ₹273.24 Crores (incl. of GST).
