CBI steps in as HC takes...

"When the deceased victim was a doctor working at the hospital, it was rather surprising as to why the principal or the hospital administration did not lodge a formal complaint. This, in our view, was a serious lapse giving room for suspicion," the court proceeded to record in its order.

The court also took a dim view of the State's decision to "reward" the college principal with a posting in another college, hours after he resigned from the RG Kar Medical College.

"It is difficult to comprehend as to why when a person submits his resignation, the concerned authorities of the State did not exercise the two options available - namely, either to accept the resignation or refuse to accept the resignation."

No offshore fund link...

The Mauritian fund was run by an Adani director and its ultimate parent was the vehicle used by two Adani associates to round-trip funds and inflate stock prices, it was alleged. FSC, the integrated regulator for the non-bank financial services sector and global business, denied the fund being registered in Mauritius. FSC said the legislative framework in Mauritius does not permit the creation of shell companies. "Mauritius has a robust framework for global business companies. All global business companies licensed by the FSC have to meet substance requirements on an ongoing basis as per section 71 of the Financial Services Act, which is strictly monitored by the FSC," the FSC said.

National Green Hydrogen Mission launched in January 2023 with outlay of Rs 20,000 crores and spread over 5 years will make India as hub of green hydrogen and its derivatives and will turn country as energy independent by 2047. She also talked about India Semi conductor mission and said India has already set up three semi conductor units for assembling, testing and packaging of semi conductor chips. The meeting comes close on the heels of attacks on the minority Hindu population, vandalism of their business and properties and devastation of Hindu temples hours in the violence that ensued for days following the ouster of prime minister Sheikh Hasina on August 5. Dhakeshwari temple is one of the prominent shakti peethas. "Rights are equal for everyone. We are all one people with one right. Do not make any distinctions among us. Please, assist us. Exercise patience, and later judge -- what we were able to do and not."

Bail is rule even in...

If the courts start denying bail in deserving cases, it will be a violation of the rights guaranteed under Article 21 (right to life and personal liberty) of our Constitution," the bench said. The verdict came while ordering the release of a retired police constable Jalaluddin Khan, who was booked under the stringent provisions of the anti-terror law and those of

the now defunct Indian Penal Code for renting out the upper floor of his house to alleged members of the banned Popular Front of India (PFI).

According to the National Investigation Agency (NIA), the probe revealed that a criminal conspiracy was hatched with an intention to carry out acts of terror and violence, leading to an atmosphere of terror and endangering the unity and integrity of the nation.

140-yr-old pond...

A few villagers took shelter in the Hanuman temple at night. The residents of Gaud colony near Panchmukhi Hanuman temple were scared all through the night. Additional district magistrate of Morena CB Prasad said the barriers around the pond fell because of the heavy rain. The district administration took several steps to avert a disaster. A team of State Emergency Response Disaster Force (SDERF) was deployed in the village, Prasad said, adding this was the reason there was no loss of property.

The court granted time to the Centre's counsel to seek instructions on the issue and listed the matter for further hearing on August 28.

Ousted Bangladesh Prime Minister Sheikh Hasina, in first comments after leaving Dhaka, has sought that rioters in the country be punished. She has also sought justice for the vandalism to the statue of her father, Sheikh Mujibur Rahman, who was also the Founding Father of Bangladesh.

In a three-page emotive statement posted on X by her son, Sheikh Hasina reminisced about the family members she lost when her father was assassinated on August 15, 1975. Mujibur Rahman's sons and their wives, his brother's family, close colleagues and associates, were wiped out the same night by the army as part of a coup.



After paying her respects to them, she turned to the present day, saying the dance of destruction across the country in the name of protest, has also led to many deaths--of students teachers, police, journalists, social workers, common people, leaders and workers of the

Awami League, pedestrians and office workers".

"For those who have lost their loved ones like me, I extend my deepest sympathy. And for those involved in this slaughter, this destruction, I demand that investigations be held and they be caught and given appropriate punish-

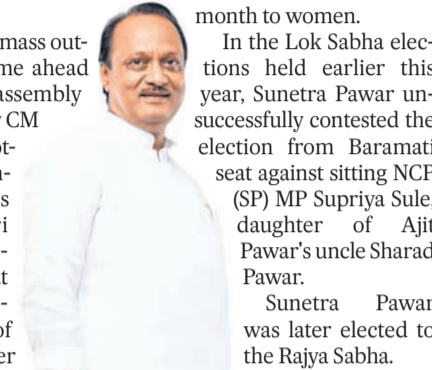

The accused, Ali had sent obscene messages to a female guest teacher and asked her to entertain him. Though the guest teacher initially ignored him, the accused continued pestering her.

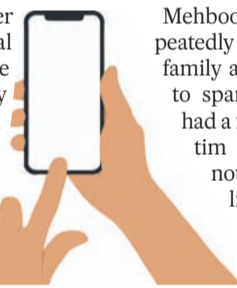
The female teacher then shared her ordeal with the family. The relatives and family members of the victim arrived at the school on Monday and questioned Mehboob Ali about his advances. They

SC closes contempt proceedings against Ramdev & Balkrishna

IANB NEW DELHI

The Supreme Court on Tuesday discharged the contempt notice issued to Yoga Guru Baba Ramdev and Patanjali Ayurved's Managing Director Acharya Balkrishna over the continued publication of misleading advertisements by the company.

Earlier on May 14, dispensing Ramdev and Balkrishna's personal appearance in further hearings, a bench of Justices Hima Kohli and Ahsanuddin Amanullah reserved its verdict in the contempt proceedings.

Justice Kohli-led Bench decided to close the matter in view of the apology tendered before



the apex court and the public apology published by Patanjali.

However, it cautioned them not to violate the undertaking furnished before the apex court in future.

In an earlier hearing, the top court had rejected the "unconditional and unqualified apology" tendered by Ramdev and Balkrishna and took strong exception over the violation of the undertaking given to the Supreme Court in November last year.

Patanjali had earlier assured the Supreme Court that it

Religious freedom does not include collective right to convert others: HC

ANI PRAYAGRAJ (UTTAR PRADESH)

The Allahabad High Court, on Tuesday observed that religious freedom does not include the collective right to convert others while rejecting the bail plea of a person accused of forcibly converting a girl to Islam and sexually exploiting her. The court stated that the Uttar Pradesh Prohibition of Unlawful Conversion of Religion Act, 2021, is intended to guarantee religious freedom to all individuals, reflecting India's social harmony. The purpose of this Act is to uphold the spirit of secularism in India.

The bench of Justice Rohit Ranjan Agarwal further noted that the Constitution grants every individual the right to profess, practice, and propagate their religion.

However, this personal right does not translate into a collective right to convert others, as religious freedom is equally available to both the person converting and the person being converted.

Bench of Justice Rohit Ranjan noted that Constitution grants everyone right to propagate, profess & practice their religion

The High Court made this observation while denying bail to a person named Azeem.

The petitioner, Azeem, is accused of forcing a girl to accept Islam and sexually exploiting her, leading to a case being registered under Sections 323, 504, 506 of the IPC and Sections 3/5(1) of the Uttar Pradesh Prohibition of Unlawful Conversion of Religion Act, 2021. The applicant-accused filed a petition in the High Court, claiming that he was falsely implicated. He asserted that the girl, who was in a relationship with him, had voluntarily left her home. He also

claimed that the girl had already confirmed their marriage in statements recorded under Sections 161 and 164 of the CrPC in the related case.

On the other hand, the government lawyer opposed his bail under Section 164 of the CrPC, which mentioned pressure to convert to Islam and described a marriage that took place without conversion.
