KHARTOUM: The Qatar-based satellite news network Al-Jazeera said that Sudanese authorities on Tuesday released its bureau chief, two days after he was detained in the African country. Security forces arrested El Musalmi El Kabbashi on Sunday, following a raid on his home in the Sudanese capital of Khartoum. That came a day after thousands protested against the military's coup last month.

6 dead, 33 hurt in twin bomb blasts in Uganda

Six people including three suicide bombers were killed and 33 others injured in twin bomb blasts in the Ugandan capital Kampala on Tuesday, police said.

Fred Enanga, police spokesperson said three suicide bombers detonated themselves at a checkpoint at Central Police Station and on parliamentary avenue.

Enanga said the injured were rushed to Mulago National Referral Hospital while counter-terrorism response teams managed to pursue a fourth suicide bomb attacker.

"They shot and injured him, and immediately after, recovered an unexploded improvised explosive device, at Nansana-Katooke, at his home, which the bomb squad were going to neutralize. We are now pursuing other members of the terror groups," Enanga said.

He said the attacks show there is still need to pre-empt, penetrate and prevent deadly attacks by domestic extremists in the days to come. "For now, the bomb threats are still active, and cannot be solved in one go, which

calls for the popular intelligence and vigilance of the community," he said.

Enanga said the blasts bear the hallmarks of the Allied Democratic Forces (ADF), an affiliate of the Islamic State in central Africa.

"It clearly shows that the ADF linked radicalized groups, still have a desire to carry out lethal attacks, on soft targets, with suicide attackers and improvised explosive devices (IED)," Enanga said.

Boris Johnson's father accused of inappropriately touching Tory MP

A senior Conservative MP has accused Boris Johnson's 81-year-old father Stanley Johnson of 'smacking her on the backside' - prompting a young journalist to claim she had also been groped by him, according to Mail Online.



Former minister Caroline Nokes, 49, said the elder Mr Johnson told her she has 'a lovely seat' during the incident, which allegedly took place at the Tory Party conference in Blackpool in 2003 when she was in her early 30s. The chairman of the Women and Equalities committee was at the time a prospective parliamentary candidate for Romsey and Southampton North, and made the allegation during a panel discussion on Sky News.

She said: 'I can remember a really prominent man - at the time the Conservative candidate for Teignbridge in Devon - smacking me on the backside about as hard as he could and going, 'oh, Romsey, you've got a lovely seat'.

Nokes then said the candidate was Johnson Sr, 81, who later failed to get elected. She added: 'I would have been in my early 30s, so old enough to call it out. I now regard it as a duty... to call out wherever you see it.'

Responding to the allegation, Johnson Sr said: 'I have no recollection of Caroline Nokes at all - but there you go. And no reply... good luck and thanks.'

But now another woman has claimed she was also inappropriately touched by Johnson Sr. New Statesman journalist Ailbhe Rea said:

'Stanley Johnson also groped me at a party at Conservative conference in 2019.

I am grateful to Caroline Nokes for calling out something that none of us should

have to put up with, not least from the Prime Minister's father.'

US journo jailed in Myanmar lands in New York

American journalist Danny Fenster, who was freed after nearly six months in jail in military-ruled Myanmar, arrived on Tuesday in the United States for an emotional reunion with his family.

Fenster, who was sentenced last week to 11 years of hard labour, was handed over Monday to former U.S. diplomat Bill Richardson, who helped negotiate the release.

He is one of more than 100 journalists, media officials or publishers who have been detained since the military ousted the elected government of Nobel laureate Aung San Suu Kyi in February.

Fenster said it "feels incredible" to be home as he arrived in New York. It's been a "long time coming, a moment I had been imagining so intensely for so long."

"Surpasses everything I had imagined." His mother, Rose, rushed over to hug him as he stepped out of a car at the airport. A friend Fenster said the first thing he would do is get a shave and a haircut.

While jailed, Fenster told his lawyer that he believed he had COVID-19, though prison authorities denied that. Late Monday, as he transited through Qatar, he told reporters that he was physically OK and had not been starved or beaten while in custody.

Fenster, the managing editor of online magazine Frontier Myanmar, was convicted Friday of spreading false or inflammatory information, contacting illegal organisations and violating visa regulations.

Pfizer allows other cos to make its Covid pill

Drugmaker Pfizer has signed a deal with a UN-backed group to allow other manufacturers to make its COVID-19 pill, a move that could make the treatment available to more people.

In a statement issued on Tuesday, Pfizer said it would grant a license for the antiviral pill to the Geneva-based Medicines Patent Pool, which would let generic drug companies produce the pill for use in 95 countries, making up about 53% of the world's population. The deal excludes some large countries that have suffered devastating coronavirus outbreaks. For example, while a Brazilian drug company could get a license to make the pill for export to other countries, the medicine could not be made generically for use in Brazil.

Still, health officials said the fact that the deal was struck even before Pfizer's pill has been authorized anywhere, could help to end the pandemic quicker.
