नई दिल्ली, (भाषा)। कांग्रेस ने सोमवार को आरोप लगाया कि मोदी सरकार की समुद्र मंथन योजना अडानी समूह को फायदा पहुंचाने के लिए शुरू की गई है।

मंजूरी दी और इसके पहले चरण के लिए 84,084 करोड़ रुपये का बड़ा आवंटन किया। उन्होंने आरोप लगाया, नरेन्द्र मोदी सरकार ने ऐसा ढांचा तैयार किया है, जिसके तहत समुद्र मंथन योजना के माध्यम से अडानी को सहायता दी जाएगी। गोहिल ने आरोप लगाया कि समुद्र मंथन योजना गौतम अडानी और वेल्स्पन समूह की संयुक्त कंपनी एडब्ल्यूईएल को सुविधा देने के लिए है। उन्होंने इस संबंध में विस्तार से जानकारी नहीं दी। उन्होंने कहा कि इस योजना के तहत सरकार 50 प्रतिशत तक वित्तीय सहायता देगी। गोहिल के अनुसार, सरकार ने स्वीकार किया है कि इस योजना की शुरुआत हाइड्रोकार्बन क्षेत्र में खोज के जोखिम को कम करने और निवेश को प्रोत्साहित करने के
