With reference to your email dated 13th January, 2026, seeking clarification on the financial results submitted by the Company, pursuant to Regulation 33 of the SEBI (Listing Obligations and Disclosure Requirements) Regulations, 2015 **wherein the EPS figures in XBRL do not match those in the PDF submitted on 13th November, 2025**, for the half year ended on 30th September, 2025.

The Company hereby confirms that the EPS as mentioned in the signed PDF is correct, i.e., 0.44, and accordingly submits the revised Integrated Filing (Finance) XBRL for the financial results for the half year ended 30th September, 2025.

Please note that the revision in the Integrated Filing (Finance) XBRL is due to a minor typographical error in the EPS, which was mistakenly mentioned as 0.88 instead of the correct figure of 0.44.

Accordingly, please note the following correct information regarding the Earnings Per Share (EPS), which should be considered and read wherever it appears in the previously filed XBRL:

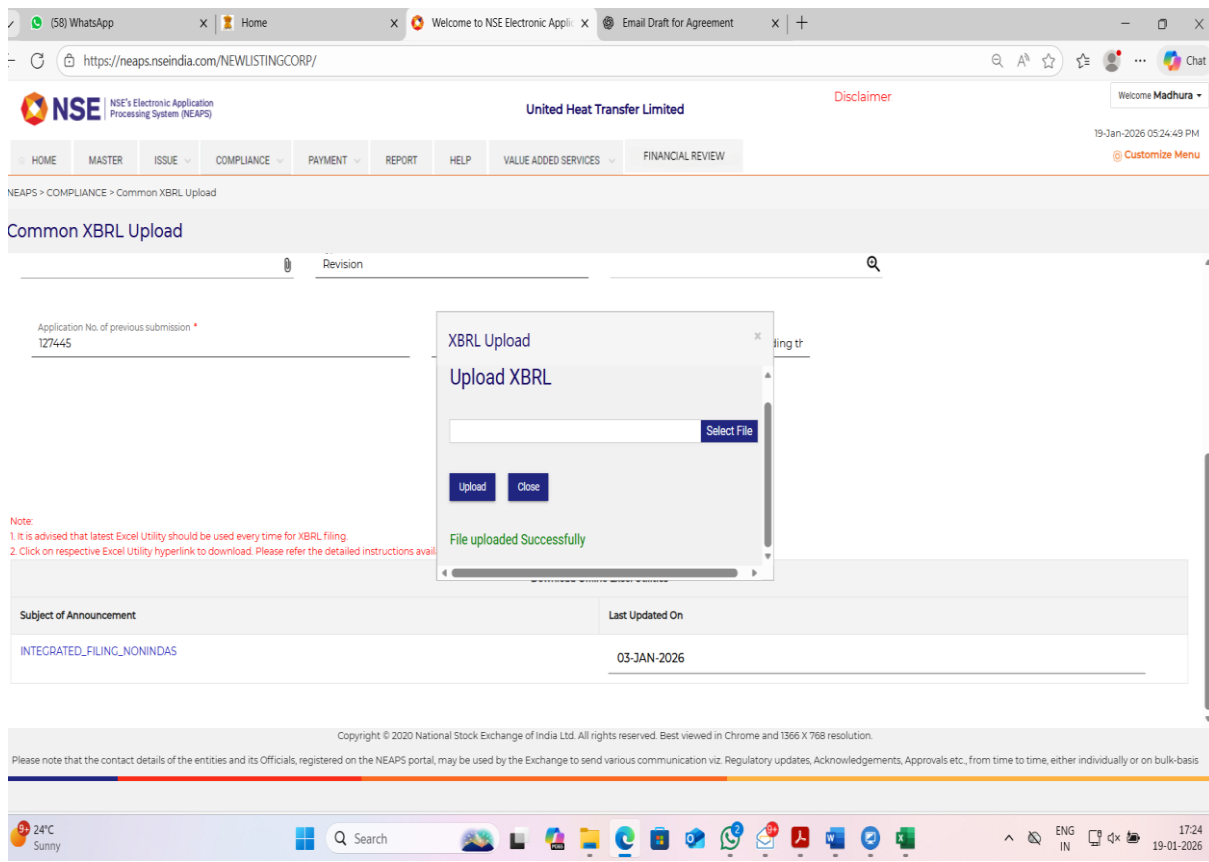
