This appeal has been filed against the Order dated 05th February, 2026 in the form of GST DRC-07 from the Goods and Services Tax (GST) Department of Maharashtra (Authority) via email on 06th February, 2026.

The said Order was issued in continuation of the Show Cause Notice dated 25th August, 2025, which was duly reported to the Stock Exchange. The Company had submitted its reply to the said Show Cause Notice on 08th September, 2025.
