Upon identifying this clerical oversight, the Company promptly submitted the revised Financial Results (Standalone and Consolidated) for the quarter and half year ended 30<sup>th</sup> September, 2025 on 27<sup>th</sup> January, 2026, with the correct Reporting Type and corresponding figures. Despite the corrective filing, daily reminders are still being received to rectify discrepancies in the financial results submitted in XBRL.
