1. Incorporation of Associate Company:

The Board has approved the incorporation of an associate company with Valecha Engineering Limited (CIN: L74210MH1977PLC019535), wherein there will be common directorship. Upon incorporation, Univastu India Limited shall hold 49% of the total paid-up share capital, while Valecha Engineering Limited shall hold the remaining 51% of the total paid-up share capital of the proposed company.

The name and other relevant details of the proposed associate company shall be intimated to the Stock Exchange upon its incorporation.

2. Appointment of Chief Operating Officer:

The Board has approved the appointment of Brig. Pravin Shinde as the Chief Operating Officer (COO) of the Company with effect from January 12, 2026.
