**Sub.: Disclosure under Regulation 30 of the SEBI (Listing Obligations and Disclosure Requirements) Regulations, 2015**

Dear Sir/ Ma'am,

This is in furtherance to our disclosure dated May 05, 2026 and pursuant to Regulation 30 of the SEBI (Listing Obligations and Disclosure Requirements) Regulations, 2015 ("SEBI LODR Regulations"), whereby the Company had informed the receipt of a show cause notice ("SCN"), dated May 04, 2026, from the Commercial Tax Officer, Guindy, South-II, Chennai South, Tamil Nadu ("GST Department") alleging certain discrepancies in the GST returns filed for the financial year 2022-23.

In continuation to the above, we wish to inform you that the Company responded to the said SCN and has now received an Order dated May 28, 2026, from the GST Department, dropping the proceedings initiated against the Company under section 73 of SGST Act, 2017. The said order records that there is no short reporting of outward liabilities in Form GSTR-3B and consequently no short payment of GST liability (i.e. No difference in turnover reported in GSTR 1 and GSTR 3B), ITC reported in the GST returns was found to be eligible and no ineligible/ irregular availment of ITC was noticed. Consequently, no tax demand, interest or penalty has been imposed on the Company pursuant to the said proceedings.

In terms of SEBI Master Circular HO/49/14/14(7)2025-CFD-POD2/I/3762/2026 dated January 30, 2026 as amended read with Regulation 30 of SEBI LODR Regulations, SEBI Circular No. SEBI/HO/CFD/CFD-PoD-2/P/CIR/2025/25 dated February 25, 2025 and Industry Standards note on Regulation 30 of SEBI LODR Regulations, the requisite information is given under the **Annexure - 1**.

Pursuant to the Company's response, the said SCN issued u/s 73 of the SGCT Act, 2017 has been dropped in its entirety by way of the Order dated May 28, 2026 and the Company's GST return is found to be in order.
