KOLKATA RAPE-MURDER CASE

SC tells protesting medics to join work from today

Raises concern over absence of key document needed for autopsy of RG Kar doctor

New Delhi/Kolkata, 9 September

The Supreme Court on Monday directed West Bengal's protesting doctors to resume work by 5pm on Tuesday, while expressing concern over the absence of a key document that was needed for the autopsy of the medic raped and murdered at Kolkata's RG Kar Medical College and Hospital, and asking the Central Bureau of Investigation (CBI) to probe it.

The apex court also flagged the at least a 14-hour delay by Kolkata Police in registering an FIR in the rape and murder of the doctor. A bench headed by Chief Justice of India (CJI) D Y Chandrachud directed the CBI to submit a fresh report by September 17 on the probe in the case.

The SC said no adverse action shall be taken against the protesting doctors on their resuming work. Earlier in the day, the Bengal government told the top court that 23 people have died as doctors are on strike protesting the rape and murder of the postgraduate medic. The next hearing on the matter is on September 17.

In Kolkata, Bengal Chief Minister Mamata Banerjee and her government continued to face sustained protests over administrative missteps in ensuring justice and allegations from the victim's parents.

On Sunday, former bureaucrat and Trinamool's Rajya Sabha member Jawhar Sircar announced that he intended to quit his membership of the Upper House "and also from politics altogether", citing the "faulty handling of the most spontaneous public movement". He also flagged the "increasing strong-arm tactics" of a section of leaders in the Trinamool.

Days after the rape-murder incident on August 9, Trinamool's deputy leader in the Rajya Sabha Sukhendu Sekhar Ray faced party backlash after publicly supporting the "Reclaim the Night" marches and calling for the CBI to question arrested former principal of the RG Kar Medical College Sandip Ghosh and Kolkata Police Commissioner Vineet Goyal.

The Bengal CM on Monday alleged that the protest is "definitely a conspiracy by the Centre and some Left parties are also involved in it". "Some people are taking advantage of the turmoil in the neighbouring country (Bangladesh). They have forgotten that India and Bangladesh are separate nations," she said at an administrative review meeting at the state secretariat Nabanna.

Banerjee also claimed she had never offered money to the deceased doctor's parents, dismissing a campaign that the family members of the victim were offered money. She urged people to "return to festivities" as Durga puja is round the corner.

The CM, who also takes care of the home department, said Kolkata Police Commissioner had offered to resign in the wake of the protests but "we need someone who knows law and order ahead of Durga puja". Rejecting claims that the construction work near the seminar hall (where the doctor's body was found) at RG Kar Medical College and Hospital was intended to tamper with evidence, she clarified that it was done for "building retiring rooms and washrooms for doctors, not for obstructing the probe".

Bengal's tally of women in police one of the lowest, Bihar's highest

Number low despite quotas in many states

In the wake of the rape-murder of a trainee doctor in Kolkata, the West Bengal government last week outlined plans to establish Aparajita special task forces in each district to probe crimes against women and children. Women police officers would lead these special task forces, it said, but women are just 9.6 per cent of the state's police force — one of the lowest in the country.

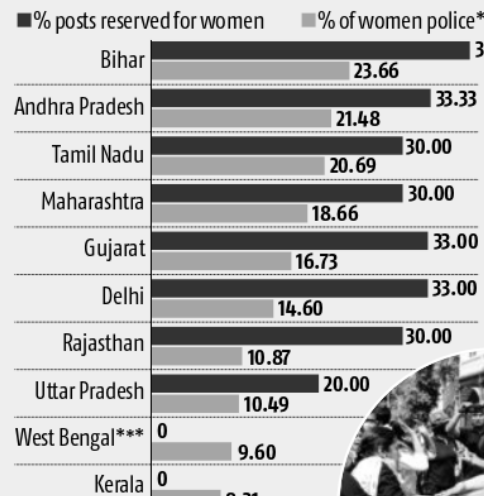
A day later on Wednesday, the Bharatiya Janata Party (BJP) government in Rajasthan approved an increase in reservation for women in the police from 30 per cent to 33 per cent. It would fulfil a promise in its 2023 Assembly election manifesto by amending the state Police Subordinate Service Rules, 1989.

However, after decades of 30 per cent reservation (it was first introduced in 1989), women comprise only 10.87 per cent of Rajasthan's 95,325 police personnel, according to the latest Bureau of Police Research and Development (BPR&D) data.

The BPR&D's latest annual data on police organisations, updated until January 1, 2023, stated that the total sanctioned strength of state police forces was 2.7 million [including civil police, district armed reserve (DAR) police, special armed police, and India Reserve Battalion (IRB)]. The actual strength was 2.1 million.

The annual report said that the availability of adequate number of women in police was essential for reducing the vulnerability of women against crimes. It said the existing

"women police population ratio" was "still very low". "Poor representation of women in police is posing serious challenges in dealing with crimes against women and women criminals," said the report, released in April 2024.

At present, the actual strength of total women police (civil + DAR + special armed police + IRB) is 263,762 (on January 1, 2023), an increase of 7.18 per cent over 246,103 in 2021. The percentage of women police is 12.32 per cent of the strength of the total police force in the country, it said.

Interestingly, with 23.66 per cent women representation in its police force, Bihar leads the way among states in implementing women reservation, followed by Andhra Pradesh, and Tamil Nadu. Among the Union Territories, Ladakh (29.65 per cent) and Chandigarh (22.47 per cent) lead the way, while Jammu and

Kashmir has only 5.38 per cent women in its police force. In Delhi Police, women comprise 14.8 per cent of its 80,583 police personnel. But the induction of women in police forces has been slow. Women reservations apply at the entry level ranks of constables and sub-inspectors. As a discussion paper from one of the National Conference of Women in Police noted, the 30 or 33 per cent quota for women in police forces "remain very much on paper". Nowhere is there a detailed recruitment plan or timeline for achieving the target, it said.

Maharashtra, for example, was the first state to reserve 30 per cent police jobs, in 1971. After five decades, it has 18.66 per cent women in its police force. The silver lining was that it had inducted a larger number of women in recent years, with the percentage of women in the state police force

up from 12.52 per cent in 2020. Despite reservations, most north Indian and northeastern states have poor representation of women in their respective police forces. In Uttar Pradesh, women account for 10.49 per cent of the police force, while Jharkhand and Chhattisgarh have 7.45 per cent and 7.60 per cent of women representation, respectively. Women representation is abysmal in the police forces of Manipur (6.48 per cent), Meghalaya (5.80 per cent), and Assam (6.69 per cent).

The Parliamentary Standing Committee on Home Affairs, in its report on police modernisation in February 2022, was "angry" that "women are abysmally underrepresented in the police force". It asked the Ministry of Home Affairs (MHA) to advise states and Union Territories to create a road map for making the representation of women police to 33 per cent of the total strength a reality.

The committee suggested that the appointment of women in police may be done by creating additional posts rather than converting the vacant posts of male constables. It said the police forces should learn from the defence forces where women are being assigned combat roles, and deploy women in "important challenging roles".

In Madhya Pradesh, when the state government increased women's reservation from 30 per cent to 33 per cent, the police headquarters and the home department objected on the ground that the majority of the policing work could only be done by men, and a greater number of women police being inducted would be detrimental for the force.

AAP releases 20 names for Haryana polls, no headway in Cong talks

Ending the suspense over an alliance with the Congress, the Aam Aadmi Party (AAP) on Monday decided to go solo in the Haryana Assembly polls as it issued its first list of 20 candidates. The decision came amid alliance talks between the AAP and the Congress that dragged on and in view of the nomination window for the polls closing on September 12. The 90-member Haryana Assembly is scheduled to go to polls on October 5.

Unemployment in India as production moved to China: Rahul

India, the US and other countries in the West are facing the problem of unemployment while China isn't as it is dominating global production, Leader of Opposition in the Lok Sabha Rahul Gandhi said at the University of Texas in Dallas on Sunday, underscoring the need to focus on manufacturing in India. Later, the BJP and TDP on Monday hit out at him over his remarks, accusing the Congress leader of "promoting" China.

SC: Accused in custody can seek anticipatory bail in another case

The Supreme Court on Monday held that an accused, who is lodged in custody in a case, is entitled to seek anticipatory bail in another matter as long as the person is not arrested in relation to that alleged offence. "No restriction can be read into Section 438 of the CrPC to preclude an accused from applying for anticipatory bail in relation to an offence while he is in custody in a different offence," said the Bench headed by CJI D Y Chandrachud.

The SC said no adverse action shall be taken against the protesting doctors on their resuming work. Earlier in the day, the Bengal government told the top court that 23 people have died as doctors are on strike protesting the rape and murder of the postgraduate medic. The next hearing on the matter is on September 17.

In Kolkata, Bengal Chief Minister Mamata Banerjee and her government continued to face sustained protests over administrative missteps in ensuring justice and allegations from the victim's parents.

On Sunday, former bureaucrat and Trinamool's Rajya Sabha member Jawhar Sircar announced that he intended to quit his membership of the Upper House "and also from politics altogether", citing the "faulty handling of the most spontaneous public movement". He also flagged the "increasing strong-arm tactics" of a section of leaders in the Trinamool.

Days after the rape-murder incident on August 9, Trinamool's deputy leader in the Rajya Sabha Sukhendu Sekhar Ray faced party backlash after publicly supporting the "Reclaim the Night" marches and calling for the CBI to question arrested former principal of the RG Kar Medical College Sandip Ghosh and Kolkata Police Commissioner Vineet Goyal.

The Bengal CM on Monday alleged that the protest is "definitely a conspiracy by the Centre and some Left parties are also involved in it". "Some people are taking advantage of the turmoil in the neighbouring country (Bangladesh). They have forgotten that India and Bangladesh are separate nations," she said at an administrative review meeting at the state secretariat Nabanna.

Banerjee also claimed she had never offered money to the deceased doctor's parents, dismissing a campaign that the family members of the victim were offered money. She urged people to "return to festivities" as Durga puja is round the corner.

The CM, who also takes care of the home department, said Kolkata Police Commissioner had offered to resign in the wake of the protests but "we need someone who knows law and order ahead of Durga puja". Rejecting claims that the construction work near the seminar hall (where the doctor's body was found) at RG Kar Medical College and Hospital was intended to tamper with evidence, she clarified that it was done for "building retiring rooms and washrooms for doctors, not for obstructing the probe".

Bengal's tally of women in police one of the lowest, Bihar's highest

Number low despite quotas in many states

In the wake of the rape-murder of a trainee doctor in Kolkata, the West Bengal government last week outlined plans to establish Aparajita special task forces in each district to probe crimes against women and children. Women police officers would lead these special task forces, it said, but women are just 9.6 per cent of the state's police force — one of the lowest in the country.

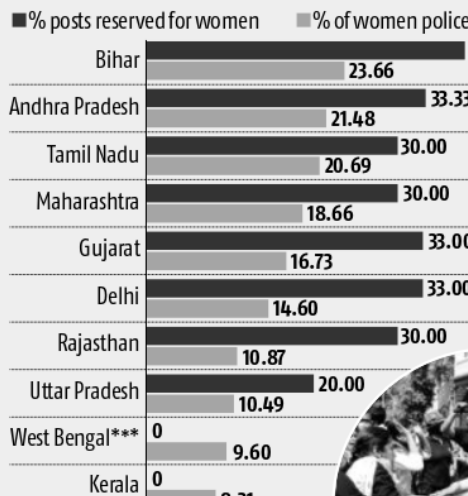
A day later on Wednesday, the Bharatiya Janata Party (BJP) government in Rajasthan approved an increase in reservation for women in the police from 30 per cent to 33 per cent. It would fulfil a promise in its 2023 Assembly election manifesto by amending the state Police Subordinate Service Rules, 1989.

However, after decades of 30 per cent reservation (it was first introduced in 1989), women comprise only 10.87 per cent of Rajasthan's 95,325 police personnel, according to the latest Bureau of Police Research and Development (BPR&D) data.

The BPR&D's latest annual data on police organisations, updated until January 1, 2023, stated that the total sanctioned strength of state police forces was 2.7 million [including civil police, district armed reserve (DAR) police, special armed police, and India Reserve Battalion (IRB)]. The actual strength was 2.1 million.

The annual report said that the availability of adequate number of women in police was essential for reducing the vulnerability of women against crimes. It said the existing

"women police population ratio" was "still very low". "Poor representation of women in police is posing serious challenges in dealing with crimes against women and women criminals," said the report, released in April 2024.

At present, the actual strength of total women police (civil + DAR + special armed police + IRB) is 263,762 (on January 1, 2023), an increase of 7.18 per cent over 246,103 in 2021. The percentage of women police is 12.32 per cent of the strength of the total police force in the country, it said.

Interestingly, with 23.66 per cent women representation in its police force, Bihar leads the way among states in implementing women reservation, followed by Andhra Pradesh, and Tamil Nadu. Among the Union Territories, Ladakh (29.65 per cent) and Chandigarh (22.47 per cent) lead the way, while Jammu and

Kashmir has only 5.38 per cent women in its police force. In Delhi Police, women comprise 14.8 per cent of its 80,583 police personnel.

But the induction of women in police forces has been slow. Women reservations apply at the entry level ranks of constables and sub-inspectors. As a discussion paper from one of the National Conference of Women in Police noted, the 30 or 33 per cent quota for women in police forces "remain very much on paper". Nowhere is there a detailed recruitment plan or timeline for achieving the target, it said.

Maharashtra, for example, was the first state to reserve 30 per cent police jobs, in 1971. After five decades, it has 18.66 per cent women in its police force. The silver lining was that it had inducted a larger number of women in recent years, with the percentage of women in the state police force

up from 12.52 per cent in 2020. Despite reservations, most north Indian and northeastern states have poor representation of women in their respective police forces. In Uttar Pradesh, women account for 10.49 per cent of the police force, while Jharkhand and Chhattisgarh have 7.45 per cent and 7.60 per cent of women representation, respectively. Women representation is abysmal in the police forces of Manipur (6.48 per cent), Meghalaya (5.80 per cent), and Assam (6.69 per cent).

The Parliamentary Standing Committee on Home Affairs, in its report on police modernisation in February 2022, was "angry" that "women are abysmally underrepresented in the police force". It asked the Ministry of Home Affairs (MHA) to advise states and Union Territories to create a road map for making the representation of women police to 33 per cent of the total strength a reality.

The committee suggested that the appointment of women in police may be done by creating additional posts rather than converting the vacant posts of male constables. It said the police forces should learn from the defence forces where women are being assigned combat roles, and deploy women in "important challenging roles".

In Madhya Pradesh, when the state government increased women's reservation from 30 per cent to 33 per cent, the police headquarters and the home department objected on the ground that the majority of the policing work could only be done by men, and a greater number of women police being inducted would be detrimental for the force.

AAP releases 20 names for Haryana polls, no headway in Cong talks

Ending the suspense over an alliance with the Congress, the Aam Aadmi Party (AAP) on Monday decided to go solo in the Haryana Assembly polls as it issued its first list of 20 candidates. The decision came amid alliance talks between the AAP and the Congress that dragged on and in view of the nomination window for the polls closing on September 12. The 90-member Haryana Assembly is scheduled to go to polls on October 5.

Unemployment in India as production moved to China: Rahul

India, the US and other countries in the West are facing the problem of unemployment while China isn't as it is dominating global production, Leader of Opposition in the Lok Sabha Rahul Gandhi said at the University of Texas in Dallas on Sunday, underscoring the need to focus on manufacturing in India. Later, the BJP and TDP on Monday hit out at him over his remarks, accusing the Congress leader of "promoting" China.

SC: Accused in custody can seek anticipatory bail in another case

The Supreme Court on Monday held that an accused, who is lodged in custody in a case, is entitled to seek anticipatory bail in another matter as long as the person is not arrested in relation to that alleged offence. "No restriction can be read into Section 438 of the CrPc to preclude an accused from applying for anticipatory bail in relation to an offence while he is in custody in a different offence," said the Bench headed by CJI D Y Chandrachud.
