- 1. On the recommendation of Audit Committee, appointment of Ms. Suchita Chatterjee as permanent Head - Internal Audit of the Bank, who was earlier Interim Head - Internal Audit, with effect from December 13, 2025, forming part of the Senior Management of the Bank.
- 2. Re-appointment of Mr. Ajay Kumar Kapur (DIN: 00108420) as an Independent Director of the Bank for a second term of 3 (three) consecutive years i.e., from March 02, 2026 to March 01, 2029 (both days inclusive), subject to approval of the Shareholders.
