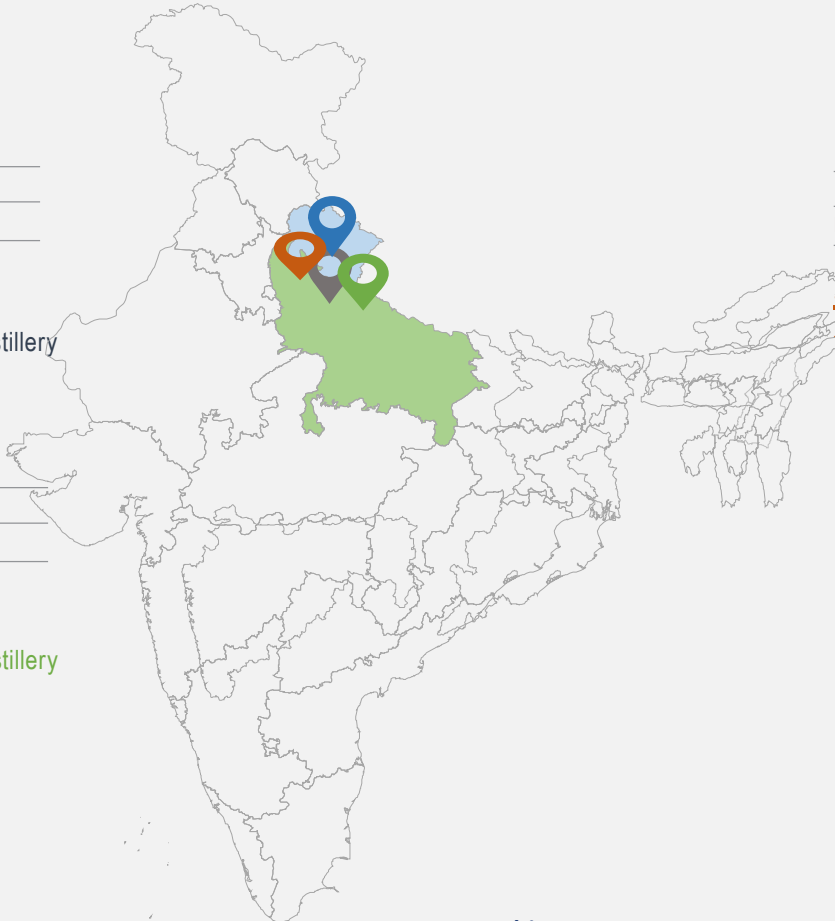

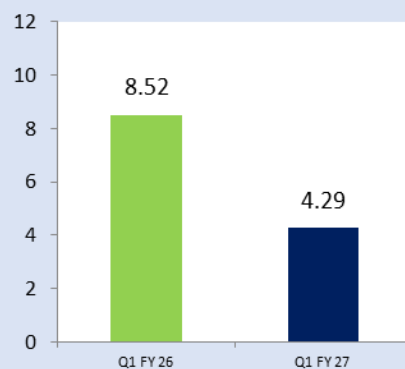

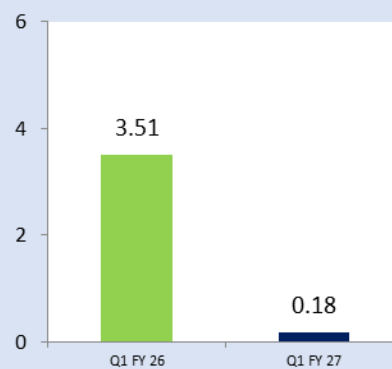

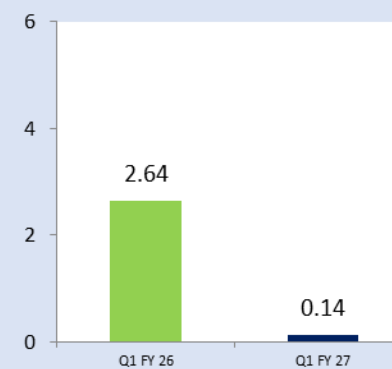
EBITDA MARGIN

(In Percentage %)



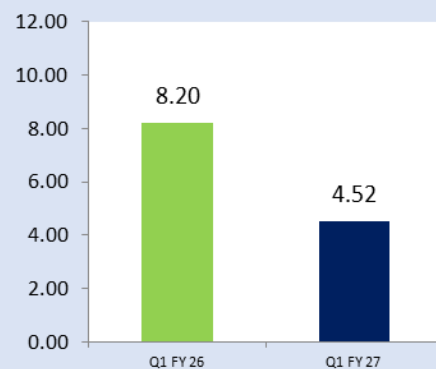
PAT MARGIN
(In Percentage %)



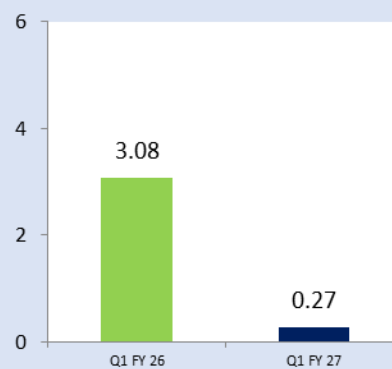

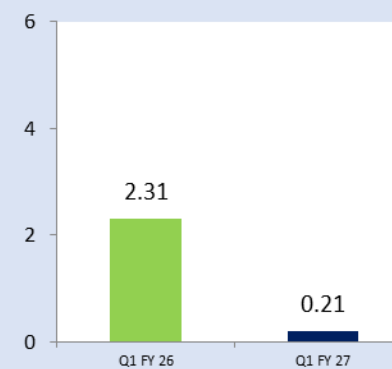
EBITDA MARGIN

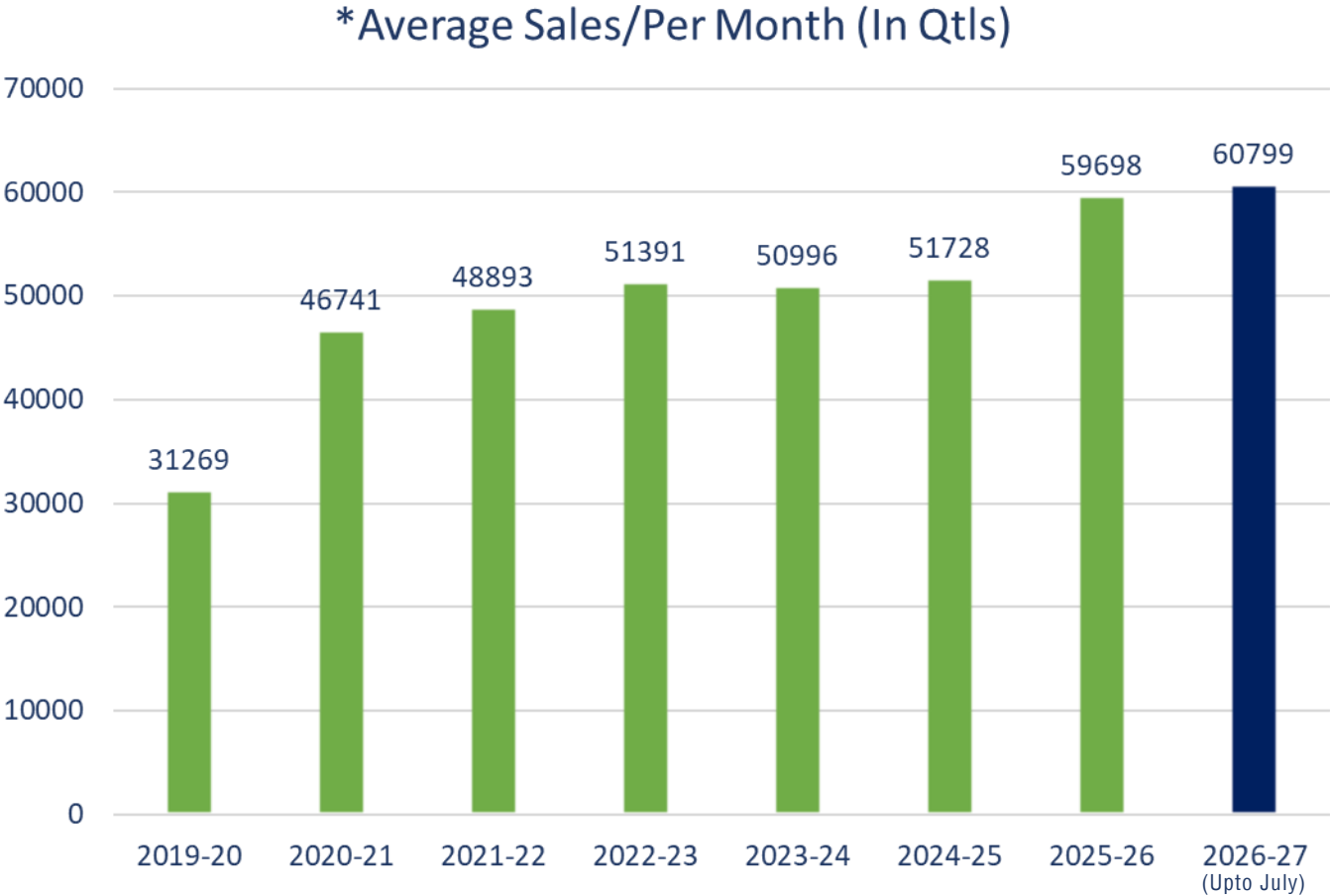

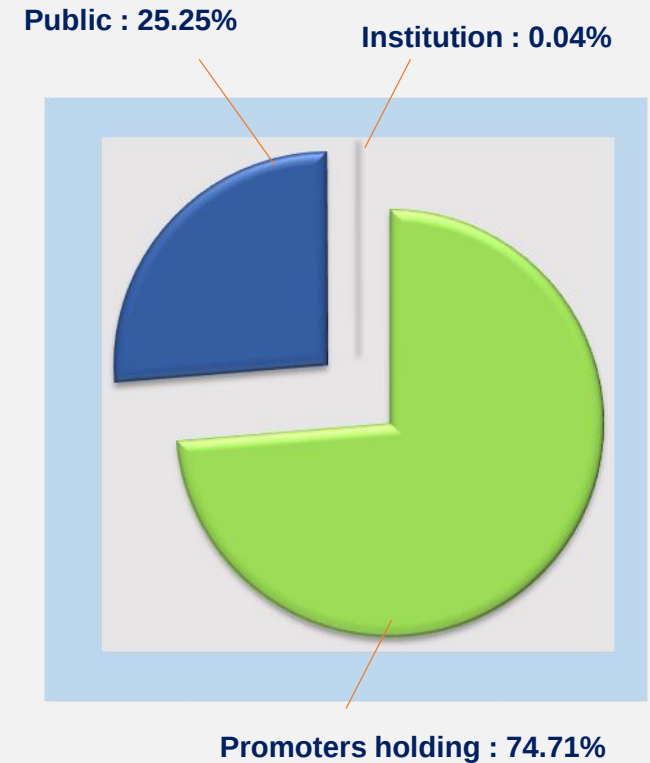
