Sub: Disclosure under Regulation 30 of SEBI (LODR) Regulations, 2015 — Update on the proposed acquisition of IDS Denmed Private Limited

Dear Sir / Madam,

Pursuant to Regulation 30 of the SEBI (Listing Obligations and Disclosure Requirements) Regulations, 2015, we wish to inform the Exchange and our investors that, after due deliberation, Vasa Denticity Limited and IDS Denmed Private Limited have mutually decided not to proceed with the proposed acquisition referenced above.

On closer review during the diligence process, both parties concluded that the two businesses are at meaningfully different stages of operating and digital maturity, and that the integration effort required to bring them together would absorb management bandwidth and operational complexity disproportionate to the value it would create in the near term. The decision is mutual and the relationship between the two organisations remains cordial. There is no financial impact on the Company arising from this decision.

For Vasa Denticity Limited, this outcome is fully consistent with our singular focus on dentalkart.com, the core of our business. Management has consciously decided to direct all of its energy, in the near term, toward strengthening this core — through deeper automation, a lean operating model, and continued expansion of our private label brands — to scale revenue to the desired levels with disciplined profitability. FY27 is, by design, a year of deep operating focus rather than inorganic expansion, and our capital allocation reflects that conviction.

We continue to see areas of potential collaboration with IDS Denmed and intend to explore these as independent entities, where value can be captured without integration overhead.

The Company's detailed strategic outlook, FY26 performance, and forward commentary will be shared shortly as part of our upcoming results announcement and investor interaction, where the management will also be available to address questions.

This intimation is made in continuation of the Company's commitment to timely and transparent disclosure.
