Pursuant to the provisions of the SEBI (Listing Obligations and Disclosure Requirements) Regulations, 2015, we hereby submit an update on the solar power project being developed by the Company at Village Mohbhatta, Tehsil Berla, District Bemetara, Chhattisgarh.

Synchronization Permission Received

We wish to inform you that the Company has received the Permission for Synchronization and Parallel Running for the 50 MWp-DC Solar Power Plant (comprising 13.75 MWp and 36.25 MWp projects) at Mohbhatta, District Bemetara, Chhattisgarh. The permission was issued on 02 December 2025 by Chhattisgarh State Power Transmission Company Limited (CSPTCL) in respect of the project being developed through the 132 kV Pooling Substation at Village Mohbhatta by M/s SRV Solar Urja Private Limited, with connectivity to the CSPTCL grid via the 132/33 kV Substation, Saja. The Company received the said permission on 04 December 2025.

The metering installation and associated compliance formalities are currently in progress. The Company expects the commencement of power generation within the next seven days, subject to successful synchronization with the CSPTCL grid.

The Company will continue to keep the Stock Exchanges informed of further developments, as and when required.
