In Pursuant to Regulation 30 of SEBI (Listing Obligation and Disclosure Requirement) Regulations, 2015, the company has decided to undertake expansion activities as follows.

- Proposed Expansion: To increase existing Billet Capacity
- Existing Billet Capacity: 66,000 MT
- Existing Capacity Utilisation: 67.18%
- Proposed Capacity Addition: From existing to 1,50,000 MT
- Period within which proposed capacity is to be added: April 2025
- Period within which proposed capacity is expected to be fully utilized: December 2025
- Investment Required: INR 60 Crores
- Mode of Financing: 40 Crores from Bank/FI and balance from internal and other sources
- Rationale: To meet higher demand from customers and increase in productivity.
