## **Sub: Update on Capacity Expansion and Renewable Energy Projects**

Pursuant to Regulation 30 of SEBI (Listing Obligations and Disclosure Requirements) Regulations, 2015, we wish to inform you of the following developments:

### **1. Billet Capacity Expansion**

- a) The Company has completed the expansion of its Billet manufacturing capacity from 66,000 MT per annum to 1,50,000 MT per annum in June 2025.
- b) Trial runs of the expanded capacity are currently in progress.
- c) Commercial production shall commence upon receipt of the Consent to Operate (CTO) from the Pollution Control Department.
- d) The Company will duly inform the Stock Exchanges upon receipt of the approval and commencement of commercial operations.

### **2. Solar Power Projects (Total Capacity: 66.50 MWp)**

- A. **16.25 MWp, Gandai (Chhattisgarh):** Already operational.
- B. **13.75 MWp, Mohbhata, Dist. Bemetara (Chhattisgarh):**
  - a) Structure work completed.
  - b) Module installation delayed due to heavy rainfall during July 2025, which impacted site conditions and logistics.
  - c) Installation is currently in progress.
  - d) Expected to be operational by end of November 2025.
