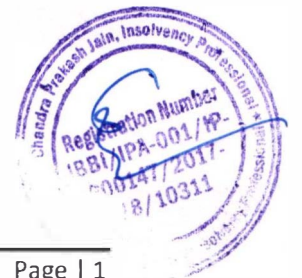

NOTES TO AGENDA

1. In accordance with regulation 21 (1) of Insolvency and Bankruptcy Board of India (Insolvency Resolution process for corporate persons) regulations, 2016, please note that a participant entitled to attend the committee of creditors meeting may participate through electronic means. If any participant wishes to attend the meeting through such means, may kindly let us know 48 hours before the scheduled time of the meeting.
2. As per Regulation 21(2) of the Insolvency and Bankruptcy Board of the India (Insolvency Resolution Process for Corporate Persons) Regulation, 2016 a participant entitled to attend and vote at the committee of creditors meeting may attend and vote in the meeting either in person or through an authorized representative. Provided that such participant should inform detail of such authorized representative along with the duly executed authority letter at least 24 hours prior to start of meeting.
3. In terms of regulation 25(3) & (5) of the Insolvency and Bankruptcy Board of India (Insolvency resolution process for Corporate persons) Regulations 2016, if all Members of the Committee of Creditors entitled to vote are not present at the Meeting, the interim resolution professional shall take a vote of the members of the committee present in the meeting, on any item listed for voting after discussion on the same.

For the members, who did not vote at the meeting on the matters listed for voting, the Interim resolution professional shall-

- (a) Circulate the minutes of the meeting by electronic means to all members of the committee and the authorized representative, if any, within forty-eight hours of the conclusion of the meeting; and
- (b) Seek a vote of the members who did not vote at the meeting on the matters listed for voting, by electronic voting system in accordance with regulation 26 where the voting shall be kept open for at least twenty-four hours from the circulation of the minutes.

4. As per regulation 13(2) of the Insolvency and Bankruptcy Board of India (Insolvency resolution process for corporate persons) Regulations 2016, the list of creditors is available for inspection.
5. After Voting at the Meeting, the decision taken on each of the items along with the names of the members of the committee of Creditors (COC) who voted for or against the decision or abstained from voting will be announced.
