Short shrift for RTI

Public interest should not be harmed by denial of information

THE DIGITAL PERSONAL Data Protection (DPDP) Act that was passed by Parliament last week is the latest blow to the Right to Information (RTI) Act. The DPDP Act seeks “to provide for the processing of digital personal data in a manner that recognises both the right of individuals to protect their personal data and the need to process such personal data for lawful purposes”. But sharing of personal data upon meeting certain conditions under the RTI Act no longer seems to be protected as “lawful purpose”. Section 44 (3) of the Act amends Section 8 (1)(j) of the RTI Act, and thereby totally exempts personal information from disclosure under the landmark accountability law.

The RTI provision allowed personal information to be disclosed if a Public Information Officer is satisfied that such information's relationship to the larger public interest or any public activity justifies this. It also held that information that can't be denied to Parliament or a State Legislature can't be denied to an RTI applicant. The DPDP Act amends this provision in such a way that an RTI applicant can't now seek “personal information” even when this information has a bearing on “public activity” or “public interest.” It even does away with the proviso on comparable rights on availing information enjoyed by an RTI applicant and Parliament/legislatures. Matters are made worse by the fact that the definition of a “person” has been made so wide that getting information under the accountability law becomes a lot more challenging. Depriving a citizen of one of the most potent means to hold the government accountable—which is what RTI and legal experts fear would be the case with the DPDP Act in its current form—doesn't augur well for democracy. A wholesale denial of information under the guise of protecting privacy—especially in a context where the government has got unbridled powers to access citizens' personal data—can't be the privacy regime the government intends to have.

There is an urgent need for course correction. Legal experts have strongly backed aligning the DPDP Act with the objectives of the RTI Act in a manner that public interest is not harmed by denial of information. Indeed, the Justice AP Shah committee that had recommended the contours of a privacy law had said in its 2012 report that such a law “should not circumscribe the Right to Information Act” and must “clarify that publication of personal data for... disclosure of information as required by the Right to Information Act should not constitute an infringement of privacy.” Now that the privacy law has been enacted, the government must move immediately to amend it suitably and lift the curbs it has placed on the scope of the accountability law.

It will do well to pay heed to the words of the National Campaign for Peoples' Right to Information: “...access to granular information, including personal information, is critical to empower people to undertake collective monitoring and ensure they are able to access their rights and entitlements”, which is “well recognised and has been adopted in various welfare programmes and schemes (as social audits)”. Chronic understaffing, amendment of the RTI Act to chip away the independence of the office of the Chief Information Commissioner, heavy pendency, inadequate information supplied, etc, have already been ailing the accountability architecture. The last thing it needs is the privacy law trumping its scope and spirit.

NASA's nuclear-powered rocket gamble is worth it

WHAT'S A GOVERNMENT space agency like the National Aeronautics and Space Administration supposed to do if private companies like SpaceX get all the spacefaring glory? One option is to double down on investments in leading-edge advancements that may not pay off for years. Super-fast nuclear-powered rocket engines are one such technology. Last month, NASA, partnering with the department of defense, gave Lockheed Martin nearly \$500 million to build and test one by 2027. Without this collaboration, two things could be in jeopardy: NASA's dream of putting boots down in more parts of the solar system and the US's upper hand in outer space.

For nearly a century, rockets have operated in a fundamentally similar manner: A tank stores fuel that, when ignited, spits out a nozzle at high speed and creates thrust. Problem is, anything that you might want to do with a spacecraft, such as manoeuvre toward Mars, requires lots of fuel, and because there are no gas stations in outer space, a craft must carry as much fuel as its operators expect it will need for its mission.

That can be a lot: Nearly half the mass of GOES-U, the 5.5-tonne weather satellite that NASA plans to launch next year, will be fuel. Last year, Canada's Telesat Corp. announced it would take a big financial hit due to insufficient fuel in a key communication satellite. In the 1950s, scientists came up with an explosive alternative fuel: Use a small nuclear reactor to heat up a propellant, such as liquid hydrogen, to much higher temperatures than what can be achieved in a chemical rocket. Such an engine would be more than twice as efficient as a traditional rocket and much faster—in part because its engines can run nonstop for weeks, accelerating faster and faster. A chemical engine would simply burn out.

Nuclear thermal propulsion (NTP) was actively researched by NASA and other agencies until the early 1970s. Such rockets weren't intended to be launch vehicles (an NTP system lacks the thrust to leave Earth's surface); instead, an NTP rocket would be carried into space on a traditional rocket and operate there. Though no reactor was ever flown, there were many successful ground tests demonstrating the concept could work—on Earth. Safety concerns and political pressures ended the programme. But NTP was never entirely forgotten, and in recent years, tech advancements have placed it on the agenda of space authorities.

For NASA, the goal is Mars. The agency aims for a human mission to the Red Planet in the 2030s. Traditional rockets can reach Mars in as little as seven months, with a round-trip mission lasting perhaps two to three years. An efficient nuclear rocket could get astronauts to the planet in as little as 45 days under one scenario, boosting their well-being—psychologically and physically—and potentially enabling more frequent trips.

For the US, it's a race against China and Russia. It operated spy satellites and other military spacecraft largely uncontested for decades. But in recent years, China and Russia have advanced their technologies and are actively taking steps to neutralise the US space advantage via jammers, anti-satellite weapons and other techniques. The military would like to move satellites out of the way, but those built with traditional technologies are either too slow or will run out of fuel if they are relocated too often. Those limitations won't be significant factors with nuclear-powered engines.

So what's the holdup? Nobody has ever tested a nuclear-powered rocket in space, and serious questions exist about how one would perform in extreme conditions. The public must also be assured that an accident during launch won't result in an environmental and health catastrophe. The good news is that such a rocket is easier to build in 2023 than it was the last time the US tried. Materials science has advanced considerably, which should help engineer a system that can withstand outer space and a nuclear reactor's heat. Likewise, modern computing power will allow complex reactor designs to be subjected to simulations and redesigns rapidly.

All of this sets the stage for the federal government's new effort. And while success is far from guaranteed, with a little luck and continued funding and commitment from Congress, the partnership between NASA and the defense department will help the US maintain and widen its lead in a new space-race era.

THROUGH THE LOOKING GLASS

THE DATA FROM INDIA'S DIGITALISATION DRIVE CAN THROW UP GRANULAR INSIGHT FOR POLICY

Building on the digital data stack

AN IMPORTANT COROLLARY of Digital India is the sheer amount of data that gets generated. Such data can power analysis offering insights for (a) a granular understanding of the patterns of economic and social activity in the country, and (b) designing appropriate and data-based policy interventions.

As the Covid pandemic eased and the economic activity went back to normal, economic analysts looked out for data sets that offered a deeper understanding of the Indian economy. Tables with high-frequency indicators (HFIs) became all the rage during Covid so that one could see at a glance how things were shaping up during and post the lockdowns. While HFI tables continue to be useful, there were limited “signals” emerging from them as the situation returned to normalcy across almost all parameters of demand, supply, trade, logistics, tax collected and spent, among others.

As part of the HFI, the value and volume of FasTag monthly swipes formed a core part of our understanding of the logistics movement in the country. FasTag is now largely mandatory for tolling on national and state highways. However, these devices are now also used for other payments, like parking and fuel. As more state highways adopt toll collections via FasTag, the monthly numbers increase due to economic activity, toll rates, and higher adoption.

Dig deeper
 Enter data from the Indian Highway Management Corporation Limited (IHMCL). IHMCL has, over the last many months, given granular data on the tolls collected at each tolling booth. This information set contains daily volume and value of toll collected from a wide variety of vehicles. Since toll plazas are neatly mapped to their latitude-longitude, such data can also be converted into visually intuitive map representations. Given all-India coverage of this data, across more than 800 toll booths, a map representation offers immediate perspective on the

economic activity in various parts of the country.

An example of what is possible is shown in the accompanying map. The circles represent location of the toll booths, relative sizes are the relative collections at each booth (or, in case of volume charts, traffic), and the colour represents change over a corresponding period, in this case, year-on-year.

Given that last year saw elevated Wholesale Price Inflation (WPI), the toll collected increased across the country. This shows up in the preponderance of “green” in the map, showing good growth in value. Many other economic takeaways

that can be built upon this basic dataset.

Data power

Such disaggregated, granular datasets, put out in public domain, create their own utility. Every user has a different perspective, and availability of such data sets allows them to explore analyses closest to their line of work and requirement. The same data set, in the hands of an economic analyst and a roads technical planner can yield different insights. Such different perspectives generate ideas on more robust design and development.

The spatial and temporal dimensions of disaggregated data offer insights to

local governments and cities which can be catered to their unique situation. Cross pollination of ideas can happen only when different constituents realize the unique positions that they are in. Such analyses create opportunities for learning and improving the efficiency and effectiveness of the system. The temporal data sets offer a perspective on evolution—interventions can be planned for engendering or managing growth, as required.

Cross sector linkage of the data and analysis can help identify the intervention that needs to be planned. For example, if a similar dataset from Railways can be paired with the roads freight data, many new types of insights can be detailed (last mile connectivity, time taken, sectors covered, etc.) As more data sets come in the public domain, each can learn from the other to design better outcomes.

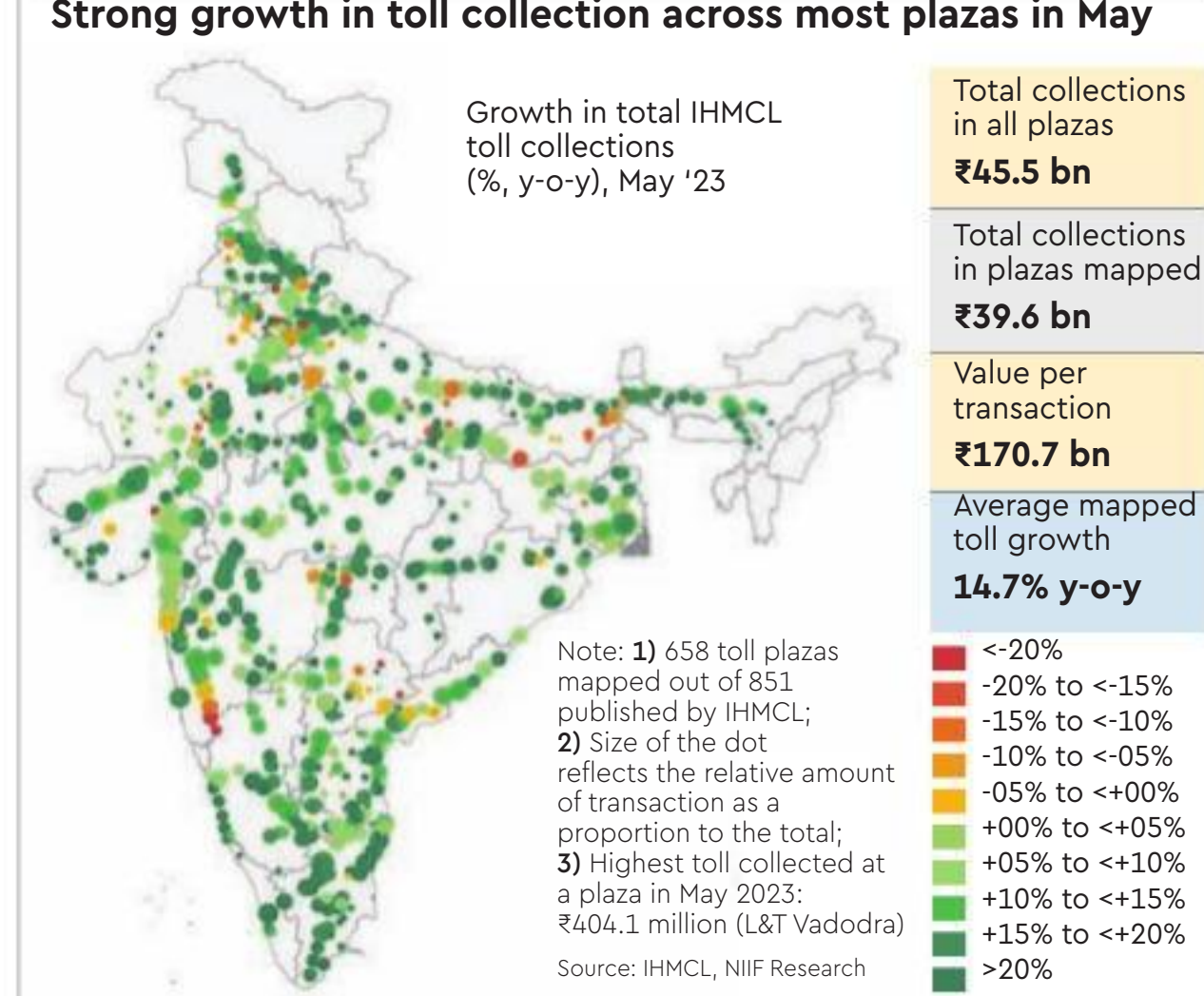
The PM GatiShakti initiative which covers a wide swath of Indian infrastructure aims to create such interlinkages between development. As more data sets get released in public domain, this will require a cadre of data analysts who can help define, analyse, and interpret the treasure trove of digital data. These new analysts and analyses can help design effective policy interventions.

Data-based analysis and development plans can bring out more effectively how the economy and society is structured and operating. These can then be weaved into designing India's infrastructure. An integrated infrastructure strategy offers investors confidence in the offtake and commercial viability of their investments. Policy interventions which reduce volatility can help bring down the cost of capital. Similarly, large datasets, regularly released, can offer investors a chance to finely price their risks—bringing down the risk premium attached to projects. Such lowering of risk perception, driven by a deeper understanding of the data, can feed into lower cost of capital.

Digital India should form the base of, and usher in an era of, Analytical India (AI).

The next step down for the rupee?

THE BIG NEWS on trade in July was that China's exports fell by 14.5% (modulated by a currency decline of 6.8%), after falling 12.4% in June (with a currency decline of 7.1%); with China accounting for 15% of global trade. It is a definitive sign that global growth is slowing. Imports fell sharply as well, reflecting the sharp slowdown within China, which, again, bodes poorly for the global economy.

A bright spot in this picture is Japan, where, although exports in July were down 0.3% in USD terms, due to a currency depreciation of 3.35% over the previous year. Exports in JPY terms actually grew by 3%; in June, Japan's exports grew by 1.5%, which, with the currency impact of 5.35%, calculated out to export growth in JPY terms of nearly 7%, which doubtlessly contributed to Japan's surprise smart 6% growth in the April-June quarter.

Indeed, Japan's export performance over the past few years has been an unheralded story. Exports rose from about ₹4 trillion in March 2020 to ₹9 trillion in October 2022; converting to USD at the average monthly exchange rate, exports grew from \$37.2 billion to \$61.3 billion over the period, a rise of 65%! Perhaps unsurprisingly, this was accompanied by a currency depreciation of a gigantic 37%.

To be sure, this sterling performance was in the backdrop of strong global trade,

which grew by 4.3% in 2021 (from the pandemic trough) and 3.5% in 2022. And, obviously, the sharply weaker yen helped the performance.

Bringing it all back home, there have been a couple of articles recently—one by an ex-deputy governor of RBI (an old friend), with whom I have frequently disagreed in the past, often to my regret—that are calling for a weaker (and, in one case, much weaker) rupee as one of the key requirements for India's growth, leveraging the export competitiveness window. The rupee is at least 5% overvalued compared to its REER and it would need to be at least a few percentage points undervalued to give exports a significant kick upwards—this would take the rupee to near 90.

Looking at our alarming trade figures—exports in July were down 15.9% (accompanied by a comparatively modest depreciation of 3.2%)—I am beginning to consider that issue more carefully. I have long felt that the rupee is already extremely undervalued, judging from the cost of personal expenses (hotel rooms, restaurants) here as compared to overseas—and, frighteningly, I am going on a holiday in Europe next week. Perhaps, even more relevant is the fact that *The Economist's* Big Mac index regularly shows the rupee as one of the most undervalued currencies. And, of course, in a world where global trade is slowing—the WTO is expecting global trade growth of just 1.7% this year—a weaker rupee may only serve to boost exporter

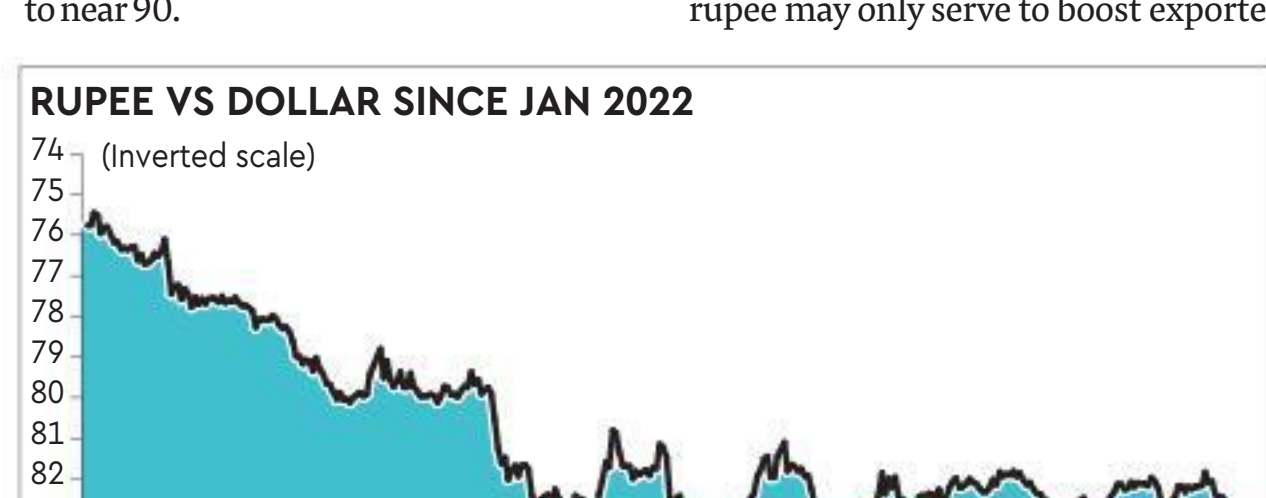
profits rather than actually generate more exports in dollar terms.

Contrariwise, and more importantly, it looks like the market has made up its mind. RBI very promptly pulled the rupee up above 83 as soon as it dared to open below that level on Monday, but over the Independence Day holiday(s), the rupee weakened to 83.50 in the NDF market. While RBI protected it with off-shore intervention, this morning the rupee opened a tad below 83 and is already trading at an all-time low of 83.16.

RBI remains on the job trying to modulate the decline—it appears convinced that the right choice is to keep the rupee as strong as possible to contain inflation. In particular, with the always-on political season, uncertainties of the monsoon and already dangerously high vegetable prices, it is important to protect against rising food price inflation, which would be exacerbated by a weak rupee given that we import nearly \$100 billion of food and food products annually.

However, that job will get increasingly difficult if/when we see a surge in long USD open interest in the futures market—in fact, it is surprising that it hasn't begun yet. In any event, it is clear that volatility will rise until a new lower range for the rupee is determined.

willingness to diversify away from the dollar-dominated trade. For sure, this development showcases an overall shift in how countries are approaching bilateral trade, and it will potentially prompt discussions about the economic and geopolitical implications among nations involved. The adoption of the LCS system with the UAE sets a precedent for innovative trade practices that can reshape international commerce. —N Sadhasiva Reddy, Bengaluru
