I, submit my report as under:

- 1) The Management of the Company is responsible to ensure the compliance with the requirements of the Companies Act, 2013 and Rules made thereunder including MCA Circulars issued by the MCA.
- 2) In accordance with the Provisions of Section 110 and other applicable Provisions of the Companies Act, 2013 read with the Rule 22 of the Companies (Management and Administration) Rules, 2014 (as amended from time to time), the Company has completed dispatch of Notice to the Members of the Company, whose name appeared on the Register of Members/ Beneficial Owners maintained by the Depositories as on cut-off date i.e. April 19, 2024 through email on April 24, 2024 to those Members whose email Id were registered with the Company/Depository Participant.

- 3) In accordance with the provisions of the Companies Act, 2013, the Company has published Advertisement in Newspapers i.e. Financial Express (English) and Mumbai Lakshadweep (Marathi) on Wednesday, April 25, 2024.
- 4) In accordance with the Provisions of Section 108 and Section 110 of the Companies Act, 2013 read with Rules made thereunder the Company has provided to its Members, the facility to cast their vote by Remote e-voting on Resolution set forth in the Notice. The Company has engaged KFin Technologies Limited (“KFintech”) as the agency to provide Remote e-voting facility. The Remote e-voting period commenced from 9.00 a.m. (IST) on Thursday, April 25, 2024 and ended at 5.00 p.m. (IST) on Friday, May 24, 2024.
- 5) Members whose name appeared on the Register of Members/ Beneficial Owners maintained by the Depositories as on cut-off date i.e. Friday, April 19, 2024 were entitled to vote on the Resolution stated in the Notice.
- 6) The Remote e-voting module was disabled and blocked by KFintech for voting on Friday, May 24, 2024 at 5:00 p.m.
- 7) After the end of Remote e-voting period i.e. 5:00 p.m. (IST) on Friday, May 24, 2024, I have unblocked the electronic votes and downloaded the Remote e-voting Report from website of the (<https://evoting.kfintech.com/>) in the presence of two witnesses, Ms. Anuradha & Mrs. Savita who are not in the employment of the Company.
- 8) The register, in accordance with Rule 20 and Rule 22 of the Companies (Management & Administration) Rules, 2015, has been maintained electronically to record the assent or dissent received, mentioning the particulars of name, address, folio number or client ID of the Shareholders, number of Shares held by them. There were no Shares with Differential Voting Rights in the Company, hence there is no requirement of maintaining of the list of Shares with Differential Voting Rights.
