**Subject: Clarification with regards to Half yearly and Quarterly submission of Financial Results for September 30, 2025**

**Ref: E-mail dated January 23, 2026 and January 19, 2026.**

Dear Sir/ Madam,

With reference to our earlier communication dated January 21, 2026, regarding the Half yearly submission of Financial Results on November 10, 2025 for the half year and quarter ending September 30, 2025. In response to your query, we further provide the following clarification that:

**Query-1**

***Financial results submitted is not as per format prescribed by SEBI-Figures of Half Year ended September 2024 not submitted in PDF.***

**Reply: -**

With reference to the captioned query, we would like to submit that the Company was listed on September 12, 2025. Accordingly, the Company was required to submit only half-year ended September 30, 2025 and year-ended March 31, 2025 financial results.

In the submitted financial results, the Company has voluntarily provided additional details to enhance transparency. At the time of dissemination, the Company had verified that several newly listed entities follow the same practice, providing comparative figures based on the latest available audited financial statements where pre-listing period comparatives are not strictly applicable. Accordingly, the Company has followed this commonly accepted practice while submitting its financial results.

The Company believes that the submissions have been made in good faith and in line with generally followed practices among newly listed companies.

**Query-2**

***Financial results submitted in XBRL with discrepancies- Quarterly Figures submitted in XBRL.***

**Reply: -**

With reference to the captioned query, we submit that pursuant to the guidance received from the Exchange, the Company was advised to upload the revised financial results by selecting the "Half Yearly" option in XBRL mode. However, while attempting to upload the same on the NEAPS portal, the system displayed an error stating that the Outcome of Board Meeting in PDF format was required to be filed first by selecting the "Half Yearly" period type, only after which the portal would permit submission of half-yearly financial results in XBRL mode.

Accordingly, the said technical issue was reported to the Exchange on January 28, 2026 with a request to resolve the same. Thereafter, upon further discussion, the Exchange advised the Company to first submit the "Outcome of Board

Meeting – Financial Results” with the correct period type and subsequently submit the “Integrated Filing – Financial Results (XBRL)” by selecting the half-yearly option.

In this regard, we wish to submit that the Company had already filed the Outcome of Board Meeting held on November 10, 2025 within the prescribed timeline. However, as advised by the Exchange, the Company has re-filed the Outcome of Board Meeting dated November 10, 2025 on the NEAPS portal solely to enable submission of the half-yearly financial results for the period ended September 30, 2025.

Further, the Company has also filed the revised Integrated Filing – Financial Results (XBRL) by incorporating the half-yearly financial results for the period ended September 30, 2025, strictly in accordance with the requirements communicated by the Exchange. The acknowledgement for the said submission is enclosed herewith for your reference. We trust that the above explanation clarifies the matter. We request you to kindly consider the same favourably and close the query.
