Modi unveils Brahmaputra tunnel, eyes Assam push

Prime Minister Narendra Modi on Wednesday stepped up campaigning across Upper Assam, combining major infrastructure announcements with welfare outreach, and expressed confidence that the BJP-led alliance will return to power for a third consecutive term in the state.

Addressing rallies in Behali, Gogamukh and Dibrugarh, the Prime Minister announced a major connectivity project, an Rs 18,500 crore underwater tunnel under the Brahmaputra near Gohpur. The project is expected to significantly reduce travel time between Gohpur and Numaligarh and improve connectivity across the region.

Beyond easing travel, the project is being projected as a catalyst for employment and economic activity, particularly for the youth in Assam.

Beginning his day in Dibrugarh, Modi struck a personal note with an early morning visit to a tea garden, where he interacted with women workers. The visit highlighted the lives of those who form the backbone of Assam's tea industry, with the Prime Minister acknowledging their contribution and describing tea as integral to the state's identity.

At the rallies, Modi highlighted the BJP's devel-

opment agenda, pointing to infrastructure expansion, welfare delivery and what he termed the benefits of a double-engine government at the Centre and in the state.

He said over 22 lakh families in Assam have received pucca houses under government schemes, with a target to extend the benefit to another 15 lakh households. Women-centric initiatives also featured prominently, with a focus on expanding the number of lakshpati baido beneficiaries.

The Prime Minister also spoke about job creation and investment, referring to plans for large-scale infrastructure development and increased support for farmers under existing schemes.

He said efforts would be intensified to address Assam's recurring flood problem through a dedicated financial outlay and river management measures.

In Gogamukh, Modi ex-

pressed electoral confidence, saying the BJP was on course for a hat-trick in Assam. He described the party's manifesto as a roadmap for development, with a focus on employment, education and protection of indigenous identity.

The rallies also saw sharp political messaging, with the Congress for what he described as years of neglect and divisive politics, while asserting that the BJP remains committed to development and safeguarding local interests.

At Behali, he reiterated plans for further infrastructure growth, noting that several bridges over the Brahmaputra have been completed in the past decade, with more in the pipeline. He also highlighted improvements in healthcare and education, including the expansion of medical colleges in the state.

Meerut brothers donate Rs 15L plot for Iran war victims

MEERUT

As conflict continues to devastate Iran, a family of timber traders from a quiet village in Meerut district has done something that has left their entire community moved.

Yasir Mustafa, Amaan Mustafa, and Subar Mustafa — residents of Rasoolpur Dhauri

village in the Janikhurd area — have donated a 125 square yard plot worth approximately Rs 15 lakh to support families of children killed in the attacks on Iran. "We felt we had to do something to help those families. We have seen our father doing such deeds and we follow the same. He passed away a few years ago," Amaan

Mustafa said. It is learnt that the plot has been donated to Anjuman Hussainia, an organisation collecting funds for victims of the conflict. The organisation's cashier, Tanveer Haider, was quoted as saying that the land will be auctioned and the proceeds used to provide direct financial assistance to affected families in Iran.

Filmmaker Ranjith held in assault case

Kochi/Alappuzha: Malayalam director Ranjith was taken into police custody on Tuesday evening after a woman actor accused him of attempting to sexually assault her on a film set. The development has drawn attention as it adds to a series of allegations previously linked to the filmmaker.

According to police, the complaint was filed with Kochi City Police on Monday. The woman alleged that Ranjith lured her into a caravan during a shoot and tried to sexually assault her, prompting immediate action from authorities.

Meanwhile, Kerala Chief Minister Pinarayi Vijayan said he was not fully aware of the allegations against Ranjith, who has been arrested in an alleged sexual assault case, but added that there were no complaints regarding the action taken so far by the authorities.

Responding to queries from reporters, Vijayan said he had no detailed knowledge of the allegations.

A left sympathiser, Ranjith had served as the chairman of the Kerala Chalachitra Academy during the tenure of second Vijayan government.

Goa nightclub fire: Luthra brothers get conditional bail

New Delhi: A local court in Goa on Wednesday granted bail to brothers Saurabh and Gaurav Luthra, owners of Birch by Romeo Lane nightclub, in connection with a fire at the establishment on December 6 that killed 25 people in North Goa's Arpora.

The Goa Police filed a chargesheet last month against 13 accused, including the Luthras, in connection with the fire. It stated that due to irresponsible acts of the accused persons, "irreparable loss... shattered 25 families, reflecting gross criminal negligence and utter disregard for human life and complete failure of the accused to adhere to statutory and safety norms".
