Heavy rain hits normal life in Odisha, schools shut

Heavy rain triggered by a deep depression over the Bay of Bengal inundated many low-lying areas in Odisha on Wednesday, prompting the administration to swing into action in worst-hit districts.

The authorities announced the temporary closure of educational institutions in more than 12 districts, officials said.

Special Relief Commissioner (SRC) held a review meeting on the prevailing situation and asked collectors of several districts to provide relief to the affected people.

District collectors of Angul, Balasore, Bargarh, Boudh, Bhadrak, Bolangir, Dhenkanal, Gajapati, Jajpur, Jharsuguda, Kandhamal, Keonjhar, Kalahandi, Mayurb-



hanj, Nuapada, Subarnapur and Sambalpur attended the meeting through virtual mode.

Odisha received an average rainfall of 83.8 mm in the last 24 hours with the highest at 390.6 mm recorded in Boudh block.

At least four blocks received rainfall of more than 300 mm, 17 experienced over 200 mm and 68

recorded between 100 and 200 mm of rain, the officials said.

A goods train derailed between Handapa and Bainda in Angul district during the day, after a boulder fell on the engine of the train due to a landslide triggered by heavy rainfall, an official said.

1 KILLED, 6 INJURED IN WALL COLLAPSE

One person was killed and six others including two children were injured in separate wall collapse incidents as heavy rain triggered by a deep depression lashed Odisha on Wednesday, officials said. Heavy rainfall in the last 24 hours has led to the swelling of water levels in different rivers in both northern and western Odisha.

Rivers like Brathmani, Baitarani, Jalaka, Bansadhara, Nagabali and Jhanjabati rivers were in spate in the state.

However, Water Resources Department sources claimed that there was absolutely no flood threat except for river Baitarani.

Baitarani river in Keonjhar, a district official said.

The state government directed district administrations to deploy teams to clear roads and regulate traffic on waterlogged streets with reports pouring in from different places of rainwater overflowing bridges, a senior official at the SRC office said.

Minor cannot be in live-in relationship: Allahabad HC

PRAYAGRAJ (UP): The Allahabad High Court has observed that a person below the age of 18 cannot be in a live-in relationship and this would be an act not only immoral but also illegal. A bench of Justices Vivek Kumar Birla and Justice Rajendra Kumar made the observation in a recent judgment dismissing a petition filed by Ali Abbas, a 17-year-old boy, and his live-in partner Saloni Yadav, 19.

'Jodhaa Akbar', 'Lagaan' art director Desai found hanging



MUMBAI: Renowned art director Nitin Desai, the creator of lavish sets for films such as "Jodhaa Akbar" and "Lagaan" as well as the TV show "Kaun Banega Crorepati", was found hanging at his studio in Karjat near Mumbai on Wednesday. He was 57.

"Desai's body was found hanging with a rope in the morning at N D Studios," Raigad Superintendent of Police Somnath Charge told reporters, adding that it seemed to be a case of suicide and the case was being investigated from all angles.

Desai's company had borrowed Rs 185 crore through two loans from ECL Finance in 2016 and 2018, and troubles with repayments started from January 2020.

months ago where he spoke about the financial problems. He said the ND Studio wasn't functioning, shootings were not happening. He hoped that work will come after the monsoon," Baldi said. A local Karjat resident said Desai came to his studio late Tuesday night. In a career spanning more than 30 years, Desai closely worked with directors like Vidhu Vinod Chopra, Sanjay Leela Bhansali, Rajkumar Hirani, and Ashutosh Gowariker, creating sprawling sets for scores of films, including "Devdas", "Swades", "Jodhaa Akbar", "Prem Ratan Dhan Payo" and "Parinda". The art director and production designer also worked for Marathi films and numerous TV shows.

Bengal Guv opens anti-corruption cell

Mamata cries interference in state's affairs

West Bengal Governor C V Ananda Bose on Wednesday inaugurated an 'anti-corruption cell' at the Raj Bhavan here, triggering Chief Minister Mamata Banerjee to term this as an attempt to interfere in the functioning of the state's administration.

While Bose said the cell would not "infringe on others' turf" but help common people forward their complaints to the competent authorities, Banerjee alleged that the Governor is "wearing a mask" and "working under instructions of the BJP".

"At the anti-corruption cell, we are trying to give voice to the voiceless. In the days of violence, Raj Bhavan is trying to be a friend of the unfriended poor. When the 'Peace Room' was set up, there were apprehensions. We will not try to infringe on the turf of others. We will certainly try to confine ourselves within the Lakshman Rekha," Bose said.

The governor had opened a 'Peace Room' at the Raj Bhavan to address violence-related complaints from people in districts during the recently held panchayat elections.

"Do not give money to any-

While Bose said the cell would not "infringe on others' turf" but help common people forward their complaints to the competent authorities, Banerjee alleged that the Governor is "wearing a mask" and "working under instructions of the BJP"

one. We will not allow that. If someone wants money, take his picture and send it to me. This was said in Cooch Behar by my constitutional colleague CM of West Bengal. This is precisely what we are trying to implement," the governor said, referring to the chief minister's recent remarks at a rally.

Banerjee, however, said this is not the job of the Raj Bhavan and he is unnecessarily interfering with the state's rights.

"I can see that he (Bose) is wearing a mask and working under the instructions of the BJP," she told reporters.

Banerjee said that the Governor's responsibilities have been specified in the Constitution.
