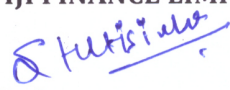

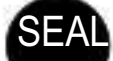

Materialism may not be as bad as you think

Viewing wealth and material possessions as a sign of success may influence satisfaction in life

Researchers have found that viewing wealth and material possessions as a sign of success yields significantly better results to life satisfaction than viewing wealth and possessions as a sign of happiness. "People simply say 'money can't buy you happiness' and just assume that materialism has a negative influence on overall well-being," said Jenny Jiao, Assistant Professor at Binghamton University in the US.

"But it's not that simple. There is a real difference between success materialism and happiness materialism," Jiao said. For the study published in the journal Applied Research in Quality of Life, researchers surveyed over 7,500 German adults. They first determined if participants had either a happiness materialistic or success materialistic mindset and then asked questions regarding current satisfaction of life, expected satisfaction of life in the future and economic motivations.

They found that happiness materialism (wealth and material consumption is a sign of a happy life) can negatively influence life satisfaction in two different ways. It can lead a person to be dissatisfied with their current standard of living, which in turn negatively influences overall life satisfaction. This can lead a person to not find satisfaction from other important areas of life such as family life, social life, and health, which negatively influences overall life satisfaction.

Success materialism (wealth and material possessions are a sign of success in life) positively influences life satisfaction by boosting a person's economic motivation. This can lead to a rise in their future satisfaction with their standard of living, which positively influences overall life satisfaction. "Your happiness should never rely on money alone, but money can be a tool to motivate you to achieve major milestones in your life, which can make you feel happier in the long run," Jiao said.

If you find that your wife is spending more time talking to the baby boy at home, check whether your relationship is heading in the right direction or not. According to researchers from University of Cambridge, mothers who are dissatisfied with their male partners spend more time talking to their infants — but only if the child is a boy.

"It's possible that the mum is trying to compensate for the poor relationship she has with her partner by putting more time and effort into her relationship with her other close male social partner, her son," said Elian Fink from the Centre for Family Research and the Faculty of Education. The quality of a couple's relationship is known to be related to developmental outcomes such as their behavior and educational attainment in school-aged children, but has been little studied in relation to parent-infant talk, despite parent-infant talk being important for the child's development.

e-glove offers human-like touch for prosthetic hand users

Researchers have developed an electronic glove or e-glove that can be worn over a prosthetic hand to provide human-like softness, warmth, appearance and sensory perception, such as the ability to sense pressure, temperature and hydration. The e-glove uses thin, flexible electronic sensors and miniaturized silicon-based circuit chips on the commercially available nitrile glove.

The e-glove is connected to a specially designed wristwatch, allowing for real-time display of sensory data and remote transmission to the user for post-data processing, said the team from Purdue University. "We developed a novel concept of the soft-packaged, sensor-instrumented

e-glove built on a commercial nitrile glove, allowing it to seamlessly fit on arbitrary hand shapes," said Chi Hwan Lee, Assistant Professor in Purdue's College of Engineering. The e-glove is configured with a stretchable form of multimodal sensors to collect various information such as pressure, temperature, humidity and electrophysiological biosignals, while simultaneously providing realistic human hand-like softness, appearance and even warmth.

Lee and his team hope that the appearance and capabilities of the e-glove will improve the well-being of prosthetic hand users by allowing them to feel more comfortable in social contexts. The glove has lifelike fingerprints and artificial fingernails.

Why you order the same food as your friend

When making food choices when we're with friends, we tend to want to match characteristics that others can measure or rank, such as size or price, but feel free to go our own way on things like flavor or shape, a new study suggests. Researchers say we do

this to avoid awkwardness. It's a familiar scenario: You go out to eat with a friend, and he or she orders a Caesar salad.

Your friend's choice inspires you to order a salad, too — only you decide to mix things up a little and choose a chef salad instead. This scenario sits at the center of a persistent marketing puzzle: Why are we more likely to

copy our friends in certain domains but not in others?

Broadly speaking, we tend to match the choices of others along ordinal lines. These might be numerical characteristics such as size, price, or number, but also more abstract value-based concepts like perceived healthiness, prestige, or authenticity. "Ordinal attributes are ones in which we believe in general that there's a particular order in which they exist," Haws says. "So in other words, one is better than another."

We don't feel the same pressure to match what the researchers call nominal attributes. The findings appear in the Journal of Marketing Research.

Stop consuming soft drinks to live longer

Greater consumption of sugar-sweetened and artificially-sweetened soft drinks is linked to a higher incidence of all-cause mortality, researchers have warned. "We found that higher soft drink intake was associated with a greater risk of death from any cause regardless of whether sugar-sweetened or artificially-sweetened drinks were consumed," said study senior author Neil Murphy from International Agency for Research on Cancer in France.

"Our results for sugar-sweetened soft drinks provide further support to limit consumption and to replace them with healthier beverages, preferably water,"

ter," Murphy said. For the study published in the JAMA Internal Medicine, nearly 452,000 men and women from 10 European countries participated. The study found that drinking two or more glasses

41,693 deaths occurred. According to the study, 43 per cent died from cancers, 21.8 per cent from circulatory diseases and 2.9 per cent from digestive diseases. The findings support public health initiatives to limit soft drink consumption.

Not just cancer, DNA changes trigger other diseases too

DNA changes throughout a person's life can significantly increase their susceptibility to heart conditions and other age-related diseases, says a research led by an Indian-origin scientist. Such alterations — known as somatic mutations — can impact the way blood stem cells work and are associated with blood cancers and other conditions, said scientists from the Universities of Edinburgh and Glasgow. These somatic mutations and the associated diseases they cause may accelerate a person's biological age — how old their body appears — faster than their chronological age.

"Previously, somatic mutations have largely been studied in cancer. Our findings suggest they play a role in other diseases, which will change the way we study disease risk," said Dr Tamir Chandra, Group Leader at the University of Edinburgh's MRC Human Genetics Unit. The study, published in the journal Current Biology, examined these changes and their potential effects in more than 1,000 older people from the Lothian Birth Cohorts (LBCs), born in 1921 and 1936. The LBCs are a group of people - now in their 80s and 90s - who sat intelligence tests as 11-year olds. They are some of the most-intensively studied research participants in the world.
