

Deeper, broader...

Former Indian ambassador Talmiz Ahmad stated that New Delhi had reached the conclusion after looking to the Arab nations, many of whom themselves were working with the Israelis "India has concluded there would be no significant Muslim or Arab backlash should it deal with Israel and therefore sees no need to be discreet about the relationship."

Whether this assessment is correct or not, what is true is that New Delhi and Tel Aviv believe that they have much in common, and therefore there is a greater need for them to work together. In his opening remarks to the Israeli foreign minister, External Affairs Minister S. Jaishankar said India and Israel have a strategic partnership, and in India's case that term has a real meaning.

NCLAT partial relief..

The order dated 18 November 2024 is modified accordingly," said the two-member bench comprising Chairperson Justice Ashok Bhushan and Member Arun Baroka. A detailed copy of the judgment is awaited.

In the same way, if the power supply surpasses ten hours for seven days in a month, the company will cut a day's salary of the general manager.

Meanwhile, the railway authorities announced a compensation of Rs 10 lakh each to kin of the deceased and Rs 5 lakh to the seriously injured persons, while those who sustained minor injuries will receive Rs 1 lakh assistance, an official statement said.

A detailed inquiry into the incident will be conducted at the level of the Commissioner of Railway Safety (CRS) to ascertain the cause and recommend necessary corrective measures, it said.

Relief and rescue operations have been launched on a war footing by the railway administration. Senior officials have rushed to the site to monitor the situation, and the injured have been shifted to nearby hospitals for treatment, it said.

The railway authorities are

providing all possible assistance and coordination to the affected passengers.

Helpline numbers have been issued for the convenience of passengers and their families, it added.

Chhattisgarh Chief Minister Vishnu Deo Sai expressed grief over the accident and said that the state government stands in full solidarity with the affected families.

A Department of Homeland Security spokesperson said Monday that the reversal in the murder case does not negate the drug conviction. The DGCA has also proposed that if a ticket is purchased through a travel agent or online portal, the "onus of refund shall lie with the airlines," as agents are their appointed representatives.

Airlines must ensure the refund process is completed within 21 working days. Additionally, airlines will not be allowed to levy any extra charge for correcting a passenger's name if the error is reported within 24 hours of booking, provided the ticket was booked directly through the airline's website.

Another proposal allows airlines to refund tickets or offer a credit shell in cases where passengers cancel due to a medical emergency.

The aviation regulator has invited comments from stakeholders on the draft CAR until November 30.

Didi leads mega anti-SIR rally

Mounting a blistering attack on the BJP and the EC, West Bengal Chief Minister Mamata Banerjee on Tuesday accused them of turning the ongoing Special Intensive Revision (SIR) of voter lists into a political tool for a "silent, invisible rigging" ahead of the 2026 Assembly polls.

She warned that the fall of the Narendra Modi government would be "inevitable" if even a single eligible voter was deleted from West Bengal's rolls during the SIR conducted by the Election Commission (EC) in the state.

Leading a massive anti-SIR rally through the heart of Kolkata, from Dharmatala to Jorasanko, the ancestral home of Rabindranath Tagore, Banerjee, with nephew and TMC national general secretary Abhishek Banerjee

by her side, alleged that the BJP and the EC were "colluding to erase voters from opposition-ruled states" while sparing those governed by the saffron party.

"The BJP is conducting SIR in Kerala, Tamil Nadu and West Bengal, but not in Assam, Tripura or other northeastern states. Why this bias? This is discrimination aimed at helping the ruling party at the Centre," she thundered before a charged crowd.

She asserted, "If even one genuine voter's name is struck off the rolls, the BJP government will be shaken to its core. The fall of this government will be inevitable."

Taking a swipe at Chief Election Commissioner Gyanesh Kumar, whom she mockingly called "kursi babu," Banerjee said, "In 2002, Bengal's last SIR took two years to complete. Why this rush to finish it in a month now?"

Desperate Didi's bid to save illegal vote bank: BJP

The Bharatiya Janata Party on Tuesday termed the foot-march undertaken by West Bengal chief minister Mamata Banerjee and other senior Trinamool Congress leaders in Kolkata against the Special Intensive Revision of electoral rolls in the state as one akin to "the 'Long March' of Maulana Bhasani, who once demanded that India's entire North East and West Bengal be ceded to East

Pakistan — now Bangladesh."

In a statement, BJP national information and technology department in-charge Amit Malviya charged that the march was Banerjee's "desperate attempt to save her illegal vote bank".

Raising the issue of illegal migration from neighbouring Bangladesh, which the BJP has repeatedly claimed to have influenced the results of elections, Malviya said in a post on "X" that "between 2001 and now, West Bengal's population has risen by 31%, but the number of voters has shot up by 67%."

Justice after 31 yrs over '93 embezzlement case

Noida postal clerk sentenced for money order embezzlement of Rs 1,575

Biswajeet Banerjee NOIDA

It took 31 years for justice to be delivered in a 1993 embezzlement case involving a money order worth Rs 1,575 at the Sector 19 post office in Noida. A local court has sentenced a former postal clerk to three years of imprisonment and imposed a fine of Rs 10,000. Failure to pay the fine will result in an additional one-year jail term.

Additional Chief Judicial Magistrate (ACJM-I) Mayank Tripathi convicted Mahendra Kumar, a resident of Kashyap Colony in Pilkhuwa, Hapur, under Sections 409 (criminal breach of trust by a public servant) and 420 (cheating) of the

Indian Penal Code.

THE CASE

According to the prosecution, on October 12, 1993, Arun Mistri, a resident of Sector 15, Noida, had sent a money order of Rs 1,500 to his father, Madan Mahto, in Samastipur, Bihar. The accused postal clerk, Mahendra Kumar, received the amount along with Rs 75 as commission but failed to deposit the money in the government account. Instead, he issued a fake receipt and handed it over to the sender. When the recipient did not receive the money, Arun Mistri lodged a complaint with postal superintendent Suresh Chandra on January 3, 1994.

BARABANKI ACCIDENT TOLL RISES TO EIGHT

The death toll in the horrific road accident on the Kalyani River bridge on the Deva-Fatehpur Road in Uttar Pradesh's Barabanki rose to eight after two injured persons succumbed to their injuries. Of the eight, six had died on the spot. Two people who were critically injured in the accident died in Lucknow hospital, wiping out

an entire jeweller's family.

According to reports, a speeding truck and an unregistered Ergta car collided head-on on the Kalyani River bridge late Monday night.

The impact of the collision was so severe that the Ergta car was completely crushed, causing panic in the area. Passersby immediately alerted the police, who rushed to the spot and sent the injured to the district hospital.
