Use drones to curb burning of waste in Delhi: NGT

New Delhi: In a bid to curb burning of waste in the city, the National Green Tribunal on Tuesday suggested use of drones, to help authorities to easily identify the sites where such incidents take place. A bench headed by NGT chairperson Justice Adarsh Kumar Goel expressed concern over rise in waste burning incidents and noted that as against 5,000 sanitary inspectors, who are tasked to control burning in the city, only 50 are available. "What is lacking is implementation. People are burning garbage in open, we have seen it with our eyes. Holistic solution to the problem has to be found. Use of technology can be invoked and drones can be put to use for preventing garbage burning," the bench said.
