# Putin, US envoy hold 'useful' Ukraine talks

MOSCOW

US envoy Steve Witkoff held "useful and constructive" talks with Russian President Vladimir Putin on Wednesday, a Kremlin aide said, two days before the expiry of a deadline set by President Donald Trump for Russia to agree to peace in Ukraine or face new sanctions.

Witkoff met Putin for around three hours on a last-minute mission to seek a breakthrough in the 3.5-year war that began with Russia's full-scale invasion of Ukraine.

Kremlin foreign policy aide Yuri Ushakov said the two sides had exchanged "signals" on the Ukraine issue and discussed the possibility of developing strategic cooperation between Moscow and Washington, but declined to give more details until Witkoff had reported back to Trump.

Russian investment envoy Kirill Dmitriev, who earlier greeted Witkoff on arrival and strolled with him in a park near the Kremlin, posted on social media: "Dialogue will prevail."

London: British regulators criticised both sides in a dispute over the future of a charity founded by Princes Harry and Seaiso of Lesotho, for allowing the issue to be played out in public and damaging the organisation's reputation.

The Charity Commission for England and Wales said it found no evidence of widespread bullying or misogyny at Sentebale, which provides support for young people living with HIV in Botswana and Lesotho. It opened a review of Sentebale's governance in April after the princes stepped down as patrons and a group of trustees, saying the relationship between the board and its chair, Sophie Chanda, was beyond repair. Chanda, who accused Harry of orchestrating a campaign of bullying and harassment to try to force her out. -AP

# US cancels \$500m mRNA vax projects

WASHINGTON

The US Department of Health and Human Services (HHS) will cancel \$500m in funding for mRNA vaccines being developed to counter viruses that cause diseases such as the flu and Covid-19.

That will impact 22 projects being led by major pharmaceutical companies, including Pfizer and Moderna.

Health Secretary Robert F Kennedy Jr, a vaccine sceptic, announced he was pulling the funding over claims that "mRNA technology poses more risks than benefits for these respiratory viruses".

Kennedy's decision to terminate the projects is the latest in a string of decisions that

have put the longtime vaccine critic's doubts about shots into full effect at the nation's health department.

"To replace the troubled mRNA programmes, we're prioritising the development of safer, broader vaccine strategies, like whole-virus vaccines and novel platforms that don't collapse when viruses mutate," Kennedy said in a video.

But infectious disease experts say the mRNA technology used in vaccines is safe, and they credit its development during the first Trump administration with slowing the 2020 coronavirus pandemic. Future pandemics, they warned, will be harder to stop without the help of mRNA.

# Bird-hit plane's nose and engine damaged

A Paris-bound Iberia flight was forced to make an emergency landing after returning to Madrid Barajas Airport following a bird hit it, damaging its nose and engine on Sunday. No injury was reported.

Chaos unfolded as smoke filled the Airbus A321's cabin, prompting flyers to don oxygen masks and cling to each other in fear. The flight, Iberia's newest and fourth A321XLR, had been delivered over a month ago.

Iberia told AeroTime, an aviation news outlet, flight IB579 struck "a large bird on the front section of the aircraft and one of its engines" shortly after de-



parture. The impact was so strong that the aircraft's nose cone was shattered triggered smoke in the cabin. Videos captured the tense moments of the smoke-filled cabin, with the sound of a crying baby and panicked people gripping oxygen masks.

# 6.8m WA a/c's with scam links deleted

New York: WhatsApp has taken down 6.8 million accounts linked to scammers targeting people around the world in the first half of this year, its parent company Meta said.

Many were tied to scam

centres run by organised criminals in Southeast Asia, who often used forced labour in their operations, according to the social media giant.

Meta made the announcement as WhatsApp rolled out new anti-scams features to

alert users to potential fraudulent activity, such as a user being added to a group chat by someone not in their contacts list. The crackdown targets an increasingly common tactic in which criminals hijack WhatsApp accounts or

add users to group chats promoting fake investment schemes and other scams. Meta said WhatsApp "proactively detected and took down accounts before scam centres were able to operationalise them."

# Nasa to put N-reactor on Moon by '30: US report

US space agency Nasa will fast-track plans to build a nuclear reactor on the Moon by 2030, according to US media. It is part of US ambitions to build a permanent base for humans to live on the lunar surface.

According to Politico, the acting head of Nasa referred to similar plans by China and Russia and said those two nations "could potentially declare a keep-out zone" on the Moon.

But questions remain about how realistic the goal and timeframe are, given recent and steep Nasa budget cuts, and some scientists are concerned that the plans are driven by geopolitical goals.

Nations including the US, China, Russia, India and Japan are rushing to explore the Moon's surface, with some planning permanent human settlements. "To properly advance this critical technology to be able to support a future lunar economy, high power energy generation on Mars, and to strengthen our national security in space, it is imperative the agency move quickly," US transport secre-

tary Sean Duffy, who was appointed temporary head of Nasa by President Donald Trump, wrote to Nasa, according to the New York Times.

Duffy called for proposals from commercial companies to build a reactor that could generate at least 100 kilowatts of power. This is relatively small. A typical on-shore wind turbine generates 2-3 MW.

The idea of building a nuclear reactor as a power source on the Moon is not new.

In 2022 Nasa issued three \$5m contracts to companies to design a reactor.

And in May this year, China and Russia announced they plan to build an automated nuclear power station on the Moon by 2035. Many scientists agree it would be the best or perhaps only way to provide continuous power on the lunar surface. One lunar day is equivalent to four weeks on Earth, made up of two weeks of continual sunshine and two weeks of darkness. That makes relying on solar power very challenging.

बारिश से राहत, रक्षाबंधन पर भी मौसम साफ रहेगा

भोपाल, (निप्र)। मध्य प्रदेश में लगातार हो रही तेज बारिश से राहत मिल गई है। मौसम विभाग में फिलहाल कहीं भी भारी बारिश का अलर्ट जारी नहीं किया है। ऐसे में रक्षाबंधन पर भी मौसम साफ रहेगा। मौसम विभाग के अनुसार भोपाल, इंदौर, उज्जैन समेत सभी जिलों में तीखी धूप खिली रहेगी। मौसम विभाग ने 9 अगस्त तक प्रदेश में कहीं भी तेज बारिश होने का अनुमान नहीं जताया है। इसकी वजह स्ट्रॉन सिस्टम की एक्टिविटी नहीं है। उत्तरी हिस्से में जरूर हल्की बारिश हो सकती है। बारिश थमने से गर्मी का असर बढ़ेगा। ज्यादातर शहरों में पारा 35 डिग्री के पार रहेगा। मध्य प्रदेश में इस मानसूनी सीजन में 28.7 इंच बारिश हो चुकी है। अब तक 44 प्रतिशत पानी ज्यादा गिर चुका है। वहीं, कोटे की 77 प्रतिशत है। पूर्वी हिस्से

में बादल जमकर बरसे हैं। मौसम विभाग के अनुसार, अगस्त के दूसरे सप्ताह में तेज बारिश का दौर शुरू होगा, जो आखिरी तक चलता रहेगा। ऐसे में बारिश का कोटा अगस्त में ही पूरा हो जाएगा। हालांकि, अब तक ग्वालियर समेत 9 जिलों में कोटा पूरा हो चुका है, लेकिन इंदौर और उज्जैन संभाग के जिलों की तस्वीर बेहतर नहीं है। मौसम विभाग की सीनियर वैज्ञानिक डॉ. दिव्या ई. सुरेंद्रन ने बताया कि इस बार अब तक अच्छी बारिश हो चुकी है। पूर्वी हिस्से यानी, जबलपुर, सागर, शहडोल और रीवा संभाग में औसत से 48 प्रतिशत और पश्चिमी हिस्से यानी, भोपाल, इंदौर, उज्जैन, ग्वालियर, चंबल और नर्मदापुरम संभाग में 39 प्रतिशत बारिश अधिक हुई है। तेज बारिश का दौर शुरू होने के बाद बारिश का कोटा पूरा हो जाएगा।

सरकार पर अलग अलग मुद्दों पर आरोप लगाते हुए उसके हिसाब से प्रतिकों के साथ कांग्रेस विधानसभा में प्रदर्शन कर रही है। ये घोटाला व्यापम पार्ट 2 है- सिंघार- नेता प्रतिपक्ष उमंग सिंघार ने कहा कि इन परीक्षा में असली उम्मीदवारों की जगह नकली सांत्वक परीक्षा दे रहे थे। जांच में फोटो, सिग्नेचर, हैडराइटिंग और फिंगरप्रिंट मेल नहीं खा रहे, फर्जी आधार कार्ड के जरिए 7411 पदों की भर्ती में खुला खेल जारी है। कांग्रेस ने आरोप लगाया कि सरकार अपने इस घोटाले के बाद भर्ती प्रक्रिया में भ्रष्टाचार को संरक्षण देकर युवाओं के साथ खिलवाड़ कर रही है। ये घोटाला व्यापम पार्ट 2 है और इसकी निष्पक्ष

न्यायिक जांच कर दोषियों को सजा दी जानी चाहिए। बनना चाहते हैं फर्जी कांस्टेबल- नेता प्रतिपक्ष उमंग सिंघार ने कहा मुख्यमंत्री जो गृहमंत्री भी हैं उनके विभाग में घोटाला हो रहा है जो युवा मेहनत कर पढ़ाई कर परीक्षा देते हैं उनका साथ धोखा हो रहा है, लेकिन व्यापम जैसे घोटाला करने वाले लोग जो सरकार में बैठे हैं वो फर्जी कांस्टेबल बनना चाहते हैं लेकिन कांग्रेस चुप नहीं रहेगी। जब तक इस पूरे घोटाले में शामिल लोगों को न्यायिक प्रक्रिया के तहत सजा नहीं मिलती, पार्टी का आंदोलन विधानसभा से लेकर सड़क तक जारी रहेगा।

किसानों से फसल खरीदने तक सीमित न रहें किसान उत्पादक संगठन: मुख्यमंत्री

भोपाल, (निप्र)। मुख्यमंत्री डॉ.मोहन यादव ने कहा कि किसान उत्पादक संगठन एफपीओ केवल किसानों से फसल खरीदने तक सीमित न रहे, बल्कि उत्पादों की प्रोसेसिंग कर बाजार में बेचें। इससे एफपीओ से जुड़े किसानों को अधिक लाभ मिलेगा और उनकी आय में वृद्धि होगी। मुख्यमंत्री भोपाल स्थित राज्य कृषि विस्तार एवं प्रशिक्षण संस्थान में एफपीओ डायरेक्टर समिट-2025 को संबोधित कर रहे थे। उन्होंने कहा कि सरकार का लक्ष्य फूड प्रोसेसिंग को 5



प्रतिशत से बढ़ाकर 95 प्रतिशत तक ले जाना है। मुख्यमंत्री ने कहा कि प्रदेश में सिंचाई रकबा 55 लाख हेक्टेयर हो गया है और 32 लाख सोलर पंप बाटने की योजना शुरू हो चुकी है। किसानों को बिजली बिल से मुक्ति दिलाने

के लिए यह एक बड़ा कदम है। राज्य में कृषि उत्पादकता अच्छी है और अब हम खाद्य प्रसंस्करण और दूध प्रसंस्करण में अग्रणी बनने की ओर बढ़ रहे हैं। आलू चिप्स का बड़ा उद्योग लगेगा- मुख्यमंत्री ने बताया कि मालवा अंचल में आलू चिप्स निर्माण के लिए बड़ा उद्योग स्थापित किया जा रहा है। साथ ही एफपीओ वेयरहाउसिंग और लॉजिस्टिक्स में भी भागीदारी करें। राज्य सरकार रोजगार आधारित उद्योगों को बिजली, पानी और भूमि की सुविधा के साथ महिला

कर्मचारियों को 6,000 और पुरुष कर्मचारियों को 5,000 रुपये प्रतिमाह अनुदान भी दे रही है। उन्होंने बताया कि मध्यप्रदेश का जैविक कपास दुनियाभर में लोकप्रिय है। चीन और वियतनाम भी अपने उत्पादों को एमपी के नाम से बेच रहे हैं। इसी को देखते हुए राज्य सरकार किसान संगठनों के साथ मिलकर किसानों को आत्मनिर्भर बनाने के लिए काम करेगी। कार्यक्रम में कृषि मंत्री एदल सिंह कंधाना और भारतीय किसान संघ के पदाधिकारियों ने भी किसानों को संबोधित किया। उन्होंने कहा कि एफपीओ को मार्केटिंग और प्रशिक्षण की दिशा में और सशक्त करने की आवश्यकता है। सरकार किसानों की हर जरूरत का ध्यान रख रही है।

मग्न में 2020 से अब तक लव जिहाद के 283 मामले

इस साल 6 महीनों में 3,742 महिलाओं से दुष्कर्म

भोपाल, (निप्र)। मध्यप्रदेश विधानसभा में सरकार ने महिला अपराध, धर्मांतरण कानून और पुलिस पर हमले जैसे गंभीर मुद्दों पर आंकड़े पेश किए। इसमें बताया गया कि जनवरी से जून 2025 तक बलात्कार और अपहरण के मामलों में बढ़ोतरी हुई है, लेकिन दोष सिद्ध की दर बेहद कम रही। साथ ही, लव जिहाद से जुड़े मामलों और पुलिसकर्मियों पर हमलों के आंकड़े भी सामने आए। मध्यप्रदेश विधानसभा में सरकार ने बताया कि जनवरी से जून 2025 तक 3,742 महिलाओं के साथ दुष्कर्म और 120 महिलाओं के साथ सामूहिक दुष्कर्म की घटनाएं दर्ज हुईं। इनमें से केवल 2.79 प्रतिशत मामलों में दोष सिद्ध हुआ है जबकि गैरपेज के मामलों में सजा का प्रतिशत मात्र 1.63 प्रतिशत है। विधानसभा सदस्य प्रताप ग्रेवाल के सवाल में सरकार ने यह जानकारी दी है। प्रदेश में वर्ष 2018 से लेकर 2024 के सात वर्षों में 54067 महिलाओं से बलात्कार हुए। जिसमें

अनुसूचित जाति 14258, जनजाति 14804 पिछड़ा वर्ग 18942 तथा सामान्य वर्ग की महिला 6063 है। 2018 में 7136 बलात्कार की तुलना में 2024 में 20 प्रतिशत की वृद्धि होकर 8518 बलात्कार तथा अपहरण 6394 से 53 प्रतिशत बढ़कर 10070 हुए। जनवरी से जून 25 तक अपहरण के 5868 प्रकरण दर्ज हुए। विधायक प्रताप ग्रेवाल द्वारा वार्षिक प्रतिवेदन तथा अतिरिक्त प्रश्न भेजे गई महिला अपराध की जानकारी में अंतर पूछने पर सरकार की तरफ से बताया गया कि वार्षिक प्रतिवेदन एवं प्रश्न दिनांक को भेजी गई जानकारी में समय का अंतराल है, पीड़िता की बरामदगी होने पर बलात्कार की घटना घटित होना पाए जाने पर अपहरण के प्रकरण बलात्कार के प्रकरण में परिवर्तित होते हैं, जिससे अपहरण एवं बलात्कार के प्रकरणों में कमी, वृद्धि होना एवं आंकड़ों में परिवर्तन होना संभव है। 283 मामलों में 197 कोर्ट में लंबित- मध्यप्रदेश में धर्मांतरण विरोधी कानून के तहत

पिछले पांच वर्षों में 283 मामले दर्ज हुए हैं, जिनमें से सबसे अधिक 74 केस इंदौर जिले से हैं। भोपाल (31), खरगोन (13), धार (13) और छतरपुर (11) अन्य प्रमुख जिले हैं। भाजपा विधायक आशिष गोविंद शर्मा ने लव जिहाद से जुड़े मामलों की जानकारी मांगी थी। सरकार ने बताया कि 2020 से अब तक 283 मामले धार्मिक स्वतंत्रता कानून के तहत दर्ज हुए हैं। इसमें से 197 मामले अभी कोर्ट में लंबित हैं। 87 मामलों में कोर्ट ने निर्णय सुनाया है। सरकार ने स्वीकार किया कि कई मामलों में पीड़िता की गवाही कमजोर रही जिससे आरोपी छूट गए। राज्य में डेढ़ वर्ष में 5 पुलिसकर्मियों शहीद, 612 घायल- जनवरी 2024 से जून 2025 के बीच प्रदेश में 5 पुलिसकर्मियों की ड्यूटी के दौरान मौत हुई और 612 घायल हुए। ये आंकड़े सरकार ने कांग्रेस विधायक बाला बच्चन के सवाल के जवाब में विधानसभा में दिए। 461 मामले पुलिस पर हमले के दर्ज किए गए।
