New draft...

This is the reason that the government is trying to take the consent of the BKS on the new draft before the farmers launch an agitation. The functionaries of the RSS and BJP's state unit president, Hemant Khandelwal, also intervened in the matter to avoid a showdown between the government and the BKS.

5K Home...

The Chief Minister announced that the mandatory two-month "Call Off" period would be done away with, compassionate assistance would be increased to Rs 360 and permission was granted to create 488 Home Guard posts for security arrangements at Ujjain's Mahakal Temple and Mahakal Lok.

Babri replica...

The smell of spices hung over the venue as volunteers ferried crates of steaming food on motorised carts to queues that stretched across the field.

Elderly villagers, women with children, daily-wage workers and mosque supporters stood patiently while committee workers directed the distribution through handheld loudspeakers. Overflow rations of pulao and chicken curry were kept ready in anticipation of a crowd far larger than initial estimates.

Contractor's claim: Indore resident Dinesh Makwana, who ran five liquor shops in Dewas with a business worth Rs 14 crore, committed suicide on November 8 by consuming poison. Before his death, he recorded a video claiming Mandakini Dixit demanded Rs 1.5 lakh from each shop, totalling Rs 7.5 lakh per month.

Another ...

suspected to be her (Dixit's) acquaintance, can be heard seeking one month to resolve the matter. Meanwhile, another person believed to be from Makwana's side is heard asking the officer to arrange Rs 1 crore within 4-5 days. Shedding light on the sordid episode, a senior police official, speaking on condition

of anonymity, said that the video of deceased Makwana in which he was accusing excise officer Mandakini Dixit of demanding a bribe of Rs 7.5 lakh every month and holding her responsible for his death, was with his mother since his death. She allegedly used this video to extort Rs 2 cr from Dixit, the police official added.

Even though Makwana's video became viral on Friday, police sources maintain that the video was recorded by Makwana before October, whereas he committed suicide on November 8.

In the video clip, Makwana is seen saying that he would repay the amount after an increase in sales following Dussehra, which fell on October 2. Based on this conversation, police have surmised that this video was recorded before October.

Finding herself in a bind due to the extortion demand, excise officer Mandakini submitted a complaint to Dewas SP on November 24, alleging that Makwana's family was demanding Rs 2 crore to settle the case. Later, on November 29, Makwana's family also submitted a complaint at Kandiya police station in Indore, demanding a thorough investigation into the case.

How Delhi...

Because for them asserting that others are buying, even if you have sanctions on us, suits their narrative, their purpose," he said.

Patanjali-Russia ink landmark wellness MoU

A historic Memorandum of Understanding (MoU) was signed in New Delhi between Patanjali Yogpeeth and the Government of Russia, marking a major step in expanding yoga, Ayurveda and wellness collaborations between the two nations. Swami Ramdev ji signed on behalf of Patanjali, while Sergey Cheremim, Chairman of the Indo-Russia Business Council and Russian Minister of Commerce, represented Moscow.

Swami Ramdev said the MoU focuses on promoting health and wellness, health tourism, skilled human resource exchange, and joint research. He noted that yoga, Ayurveda and naturopathy are already appreciated in Russia. He added that Patanjali aims to take India's wellness sciences to nearly 200 countries, with Russia as the strategic gateway.

The first major objective is to expand Patanjali's wellness services in Russia. Both sides will conduct research on reversing ageing, enhancing longevity, and detecting serious diseases years before symptoms appear. The second aim is to strengthen

spiritual and cultural ties by taking India's yogic and sage traditions to Russia. The third objective is to provide Russia with skilled labour and trained yogis. Under the Prime Minister's Skill Development Scheme, Patanjali has trained over two lakh people and will supply trained professionals to Russia. The MoU also focuses on promoting leading Indian brands in Russia and Russian brands in India. Swami Ramdev emphasized that India and Russia share deep emotional, cultural, and political ties and remain inseparable friends.
