BJP announces two...

She will campaign in the election. We all respect her," he told reporters. He said the election management committee has experienced leaders to manage day-to-day poll-related activities. Singh also said the election manifesto committee has representation from all sections of society, including Scheduled Castes, Scheduled Tribes and Other Backward Classes, so that their expectations can be incorporated in the manifesto. BJP's state election in-charge and Union minister Pralhad Joshi said both state and central leaders of the party will campaign for the crucial polls. Arun Singh said the party will take out four "Parivartan Yatras" in the state in September. These will be led by different leaders. "Our strategy is ready. I have full confidence that people will give the mandate to the BJP and we will get a historic victory," he said. Asked about the role of Vasundhara Raje, Joshi said the state and central leaders will campaign in the elections as required. "Where a state-level leader will be required, a state-level leader will campaign and where there is a need for a central leader, a central leader will do campaigning," he said. After the announcement of the committees, the party launched a membership drive at Khandelwal Sabha Bhawan in Jaipur's Vaishali Nagar. Pralhad Joshi, Arun Singh, C P Joshi, Union ministers Gajendra Singh Shekhawat and Kailash Chaudhary, national secretary Alka Gurjar and other leaders were present in the drive. Later, a meeting of the BJP core committee was held in the party's state headquarters in which its members discussed organisational and election-related matters. The meeting was attended by Pralhad Joshi, Arun Singh, C P Joshi, Rajendra Rathore, Satish Poonia, Kailash Chaudhary and a few other members.

16 new faces...

Former Chhattisgarh minister Ramvihkar Netam would contest from Ramanujganj (ST) seat where he had suffered defeat in 2013 against incumbent Congress MLA Brihaspat Singh. Both Vijay Baghel and Netam did not contest the 2018 assembly elections. BJP spokesperson Devlal Halwa Thakur would contest from Daundi Lohara (ST) seat while former MLAs Sanjeev Shah, Shravan Markam and Lakanlal Dewangan would contest from Mohla-Manpur (ST), Sihawa (ST) and Korba seats, respectively. Rajnandgaon Zila Panchayat president Geeta Ghasi Sahu has been fielded from Khujji seat while Rajnandgaon Zila Panchayat vice president Vikrant Singh, a relative of senior BJP leader and former chief minister Raman Singh, will contest from Khairagarh seat.

The other candidates in the list are Bhulan Singh Maravi (from Premnagar seat), Prabhoj Minj (Lundra-ST), Mahesh Sahu (Kharsia), Harishchandra Rathia (Dharamjaigarh-ST), Pranav Kumar Parpachhi (Marwahli-ST), Indrakumar Sahu (Abhanpur), Rohit Sahu (Rajim), Asharam Netam (Kanker-ST), Maniram Kashyap (Bastar-ST), Laxmi Rajwade (Bhatgaon), Shakuntala Singh Portha (Pratappur-ST), Sarla Kosaria (Saraipali-SC) and Alka Chandrakar (Khallari). Senior journalist and political analyst R Krishna Das said the BJP seemed to have declared candidates in the first list for the seats where there were not much differences within the party over the nominees. While in 2018 the saffron party had drawn blank in all 21 seats, even in 2013 (when it retained power in the state) it had suffered defeat in 16 of these seats, he noted. Declaration of candidates so early will benefit the candidates who will have sufficient time for preparations, he added.

Caretaker's son sold...

In 1972, Dr. Ratnakar Peter Das, a tribal from Chhattisgarh, took over the charge as superintendent of Mission Hospital Dhar. Dr Das got revenue records manipulated in 1965 to get his name registered as caretaker. Despite Dr Das's claim that he was only the caretaker and not the owner, the United Church of Northern India in 1990 staked claim over the land. On December 20, 2004, ADJ-IV of Dhar District Court ruled that Dr Das and his family did not hold ownership title of the land. Contrary to court order, after Dr Das's death, his wife Dr Ila Das executed a lease deed of 0.451 hectare in favour of Sudhir Jain. In 2009, a power of attorney was made in the name of another accused Aklesh Sharma, who later sold 36 plots on the land to people for merely Rs 20 lakh. Later late Dr Das's son Sudhir Das illegally executed 14 sale deeds and sold over 1.6 lakh square feet of land to different people.

Chandrayaan-3 Lander...

According to ISRO, the lander was separated from the propulsion module at an orbit of 153 km x 163 km around the moon. Meanwhile, the Propulsion Module continues its journey in the current orbit for months/years, said ISRO. "The SHAPE payload onboard it would perform spectroscopic study of the Earth's atmosphere and measure the variations in polarization from the clouds on Earth - to accumulate signatures of Exoplanets that would qualify for our habitability! This payload is SHAPED by U R Rao Satellite Centre/ISRO, Bengaluru," ISRO added. The main purpose of India's third moon mission costing about Rs 600 crore is to land the lander softly on the moon. The Chandrayaan-2 mission failed as the lander called 'Vikram' crashed on to the moon. According to the ISRO, the lander is expected to make a soft-landing near the South Pole of the moon on August 23 at 5.47 p.m. The lander will descend to the moon from a height of about 100 km from the moon's surface.

Surjewala is Congress...

In the last five years since former CM Kamal Nath took the charge as state Congress president, the party has replaced three state in-charge. Before Agarwal, Deepak Babaria and Mukul Wasnik were given the state responsibility. There were reports of 'discord' between Nath and Agarwal and a 'faction dissatisfied' with state party president had held a closed-door meeting with Agarwal, but the pictures of the same had gone viral on social media. Several times Agarwal had advocated 'no CM face for assembly election', although many state and national level leaders reposed faith in Nath. The AICC finally replaced Agarwal with Surjewala. An organisational overhaul of several state units of the Congress is underway and more appointments are likely to be made in the coming days.

Three pilots lose lives within 3 days; 2 in India

In a chilling incident, three pilots lost their lives in India and globally within a span of three days, with two of them passing away due to cardiac arrest in the country. An IndiGo pilot scheduled for a flight from Nagpur to Pune lost consciousness and collapsed at the boarding gate on

Thursday, said the airline official.

He was declared dead after being taken to a hospital. "We are saddened at the passing of one of our pilots in Nagpur earlier today. He took unwell at Nagpur airport and was rushed to the hospital where he unfortunately passed away. Our thoughts and prayers are with his family and loved ones," IndiGo said in a statement.

The land for the wax museum is earmarked behind the famous Afem Kothi in the city. The museum is to be constructed in an area of around 10,000 square meters. The selected firm will also take care of repair, upkeep and overall operations.

Landslides block highway in Manipur

AT LEAST 500 TRUCKS STRANDED

IMPHAL: Heavy rains triggered massive landslides in Manipur's Noney district, blocking the Imphal-Silchar highway due to which at least 500 goods vehicles are stranded, officials said on Thursday.

The landslides happened on the National Highway 37 between Irang and Awangkhum part 2, Khongsang and Awangkhum, and Rangkhui village on Wednesday, they said.

Work is underway to clear the road, and re-start movement of traffic, officials said.

Incessant rains over the last few days triggered the landslides, they said.

At least 500 goods vehicles are stranded in different parts of the highway due to the landslides, they added.

Prez launches 'VINDHYAGIRI'

KOLKATA: Describing the indigenous construction of an advanced stealth frigate for the Indian navy, 'Vindhyagiri' by Kolkata's Garden Reach Shipyards as a symbol of India's self-reliance in shipbuilding, President Droupadi Murmu on Thursday launched the ship at the dock on the banks of the river Hooghly here.

She also said the production of the advanced frigate was a symbol of Atmanirbhar Bharat and of technological advancement made by the country.

"I am very happy to be here at the launch of Vindhyagiri. This event marks a move forward in enhancing India's maritime capabilities. Vindhyagiri is also a step towards achieving the goal of Atmanirbhar Bharat through indigenous ship-building," she said at the programme.

WHO CHIEF PRAISES INDIA'S RICH HISTORY OF TRADITIONAL MEDICINE

GANDHINAGAR: Praising India for its "rich history" of traditional medicine like Ayurveda and yoga, WHO chief Dr Tedros Ghebreyesus on Thursday stressed the need to integrate this ancient medicinal knowledge into the national health system of countries.

The Director-General of the World Health Organization was speaking after inaugurating WHO's first-ever Global Summit on Traditional

Medicine in Gandhinagar as part of the G20 Health Minister's Meetings commenced at the Mahatma Mandir convention centre.

"India has a rich history of traditional medicine through Ayurveda, including yoga, which has been

shown to be effective in alleviating pain. The Gujarat Declaration, the main outcome of this summit, will focus on integration of traditional medicines in national health systems, and help unlock the power of traditional medicine through science," he said.

बैंक की हबहू वेबसाइट बनाकर लाखों ठगे

एडीसीपी राजेश दंडोतिया के मुताबिक, आरोपितों के खिलाफ रितेश हिरवे और जितेंद्र द्वारा शिकायत दर्ज करवाई गई थी। आरोपित आरबीएल बैंक क्रेडिट कार्ड विभाग की लिंक लोगों को भेजते थे। ग्राहक लिंक पर क्लिक करता तो उसे क्रेडिट कार्ड रिवाइड पाईट का झांसा देते और कार्ड के ओटीपी, सीवीवी नंबर आदि लेकर खातों से रुपये निकाल लेते थे। आरोपितों द्वारा बैंकों की हबहू वेबसाइट बना ली गई थी। गिरोह में वेब डिजाइनर भी शामिल है।

मुहाड़ी वॉटर फॉल में डूबा युवक

इंदौर। शहर से 30 किलोमीटर दूर मुहाड़ी फॉल में 17 वर्षीय युवक निखिल लश्करी डूब गया। पांच घंटे बाद उसका शव पानी से खोताखोरों को मिला।
