In accordance with Regulation 30 of the SEBI (Listing Obligations and Disclosure Requirements) Regulations, 2015, this is to inform you that in relation to decade-old export-import transactions involving certain unrelated third parties, with whom the Company had no dealings or underlying interests, the Company's name appears to have been included among entities covered in a wider inquiry, reportedly based on questionable inputs.

A stay had been granted in the matter in 2023 by the Hon'ble High Court of Gujrat; and complying to the directions issued by the Hon'ble High Court the company will also be approaching the relevant adjudicating authority.

Officials from the Enforcement Directorate visited the Company's office and a promoter's residence on 12 November 2025. The Company extended full cooperation to the authorities, and the proceedings concluded amicably without any adverse developments.
