In continuation of our letter dated April 21st, 2026 and pursuant to Regulation 30 of the SEBI (Listing Obligations and Disclosure Requirements) Regulations, 2015 ("SEBI LODR Regulations"), we hereby inform you that the Company has, on May 07th 2026, acquired 100% equity shares of the equity share capital of Leelajit Foundation (CIN: U88900GJ2026NPL171985), With this acquisition, Leelajit Foundation has become a Wholly Owned Subsidiary of the Company.

The aforesaid transaction qualifies as a Related Party Transaction in terms of the applicable provisions of the SEBI LODR Regulations, as the Promoters are related parties. However, the transaction does not exceed the materiality thresholds prescribed under Regulation 23 of the SEBI LODR Regulations and the Company's Policy on Materiality of Related Party Transactions.
