Sub: Intimation of Re-classification of Outgoing Promoters to the 'Public' Category pursuant to Regulation 31A(10) of SEBI (Listing Obligations and Disclosure Requirements) Regulations, 2015 (Listing Regulations)

Ref: Open Offer made under Securities and Exchange Board of India (Substantial Acquisition of Shares and Takeovers) Regulations, 2011 (SEBI SAST Regulations)

This is in reference to the Open Offer for the acquisition of 36,27,000 Equity Shares representing 26% of Voting Share Capital of **Vilin Bio Med Limited** ("Target Company"), which successfully concluded on September 15, 2025.

Pursuant to execution of the Share Purchase Agreement dated March 27, 2025 and the subsequent completion of Open Offer, the Management and Control of the Target Company have been transferred to the Acquirer(s).
