**Subject: Intimation under Regulation 30 of SEBI (Listing Obligations & Disclosure Requirements) Regulations, 2015 – Disclosure of outcome of litigation**

**Ref: Communications dated 20<sup>th</sup> July, 2023, 21<sup>st</sup> July, 2023 and 26<sup>th</sup> July, 2023, 2<sup>nd</sup> July, 2025 and 5<sup>th</sup> August, 2025**

Pursuant to Regulation 30 of SEBI (Listing Obligations and Disclosure Requirements) Regulations, 2015 and in continuation to our earlier communications latest being dated August 5, 2025 wherein the Company had informed that Supreme Court of India vide its order dated August 1, 2025 while disposing off the special leave petition filed by the Company against order of Division Bench of Hon'ble Delhi High Court, allowed the Company to deal with the inventory of products under the mark "CARLTON" subject to terms set out therein. The order further contains a direction to the Hon'ble Delhi High Court to try and dispose of Civil Suits between the Company and Carlton Shoes Ltd as expeditiously as possible.

In compliance with the said order, the Company was permitted to sell its inventory under the brand name "CARLTON" until May 31, 2026. Accordingly, the Company has sold substantially all of its inventory under the "CARLTON" brand on or before May 31, 2026. The Company has stopped/discontinued selling product under the mark "CARLTON" from June 1, 2026 onwards in compliance with the directions of the Hon'ble Supreme Court of India. The disclosure is given as a good corporate governance and there is no material financial impact on the Company.

Further, the disclosures as required under Schedule III of SEBI LODR Regulations 2015 and additional details as required under SEBI Circular No. HO/49/14/14(7)2025-CFD-POD2/1/3762/2026 dated January 30, 2026 is enclosed as **Annexure 1**.
