Dear Madam,

In continuation of the intimation submitted to the stock exchange on January 13, 2026, and pursuant to Regulation 30 of the SEBI (Listing Obligations and Disclosure Requirements) Regulations, 2015, and with reference to the observations raised by the National Stock Exchange of India Limited during the processing of the Company's application for in-principle approval for the proposed preferential issue of equity shares and convertible warrants, the Company hereby places the following clarifications on record:

1. Pre-Issue and Post-Issue Shareholding of Proposed Allottees
