Pursuant to Regulation 30, Schedule III, of SEBI (LODR) Regulations, 2015 we are pleased to announce that, Vishnusurya Projects and Infra Limited has started operating the mining unit with 2 Crusher plants (**Model - METSO 200TPH**) situated in Kariasandhiram Village Soolagiri Taluk, Krishnagiri District today, January 24, 2025.

The installed capacity of the **METSO Crusher plants is 15.75 Lakhs MT per annum.**

Further, Vishnusurya already has two aggregates units (Stone Quarry, Crusher & Msand plant). First one in Aruppukkottai, Virudhnagar District with installed production capacity of 9.80 Lakhs MT per annum and second one in Vandavasi, Tiruvannamalai District with installed production capacity of 13.75 Lakhs MT per annum.
