'If B'gavi divided, make Chikkodi, Gokak new dists'

Demand for Gokak to be district HQ, Jarkiholi's statements welcomed

GOKAK District Steering Committee president Shri Murugharajendra Swamiji demanded that Belagavi district with 18 assembly constituencies should be divided, and Gokak and Chikkodi be carved out as new districts.

Welcoming Belagavi district Minister Satish Jarkiholi's statement that the government is considering considering a proposal to create Gokak and Chikkodi districts by dividing Belagavi district, he said the people of Mudalgi and Gokak should support independently and cooperate to make Gokak the new district headquarters.

When Jarkiholi comes to Gokak, a memorandum would be submitted to him and through the tahsildar, another

memorandum would be sent to the chief minister, requesting for a new district of Gokak.

Dr Rajendra Sanakki, Basagowda Patil, president of Advocates Association Basavaraj Kotagi and Dr Mahantesh Kadadi said that for the last four decades, they have been protesting for Gokak district as it has seen a lot of development compared to other taluk centres of the district.

On this occasion, Municipal Council members Jayananda Hunnchyal, Basavaraj Arenavar, leaders Chandrasekhar Konnur, Vivek Jatti, Vithal Savadatti, Kenchagowda Patil, Bhutappa Vadera, Lakshmana Ganappagola, Erappa Birangaddi, and Durgappa Shastri Gollar were present.

Over 6k people duped with bumper draw lure

VIJAYAPURA: A local agency of the district allegedly duped over 6,000 people with bumper draw in which the victims were promised expensive items if they participated by paying Rs 600.

The Maniyar Enterprises has allegedly cheated people with the lure of giving lottery prizes and reportedly swindled huge amounts of cash in Devarahippuragi town of the district.

The agency has reportedly collected Rs 600 from each person for a bumper lottery. The

participants were assured expensive items including motorcycles, TVs, gold biscuits, mobile phones etc, among the 100 items which were listed.

When the day of announcing the draw arrives, over 6,000 people had congregated near the MDG Lodge in Devarhappuragi. But the owners of the agency never turned up.

When people tried to call the accused Shahnavaz Maniyar, Ismail Maniyar, Abdul Razak Maniyar, Ghaus Mohdin Maniyar and Mohammad Mustafa

Maniyar, the phones were switched off.

According to sources, the accused have allegedly cheated people of Devarahippuragi, Muddebihal, Indi, Basavabagewadi and Sindgi taluks.

The duped people filed a complaint with the Devarahippuragi police, and a case has been registered under section 420 of IPC. Ismail Maniyar and Mohammed Mustafa Maniyar have been detained, and the police have launched a search for the others.

3-member gang busted, items worth Rs 3.75 lakh seized

Belagavi: A three-member gang was nabbed in connection with a case of burglary and stolen goods worth Rs 3.75 lakh have been recovered at Murgod on Thursday. Two of the arrested are minors. The third is 21-year-old Shakeel Hussiansab Sayyed, a resident of Yargatti. Police have recovered one goods rickshaw, two bikes, 10 bundles of wire and more. During interrogation, the trio has confessed to committing three burglaries in Yargatti jurisdiction. Under the guidance of Dr Sanjeev Patil, Murgod Police Inspector IM Mathpati and his team arrested the accused.

Gold, silver ornaments burgled, case filed

Belagavi: Burglars made away with 15 g of gold ornaments, 250 g of silver ornaments and Rs 7,000 in cash from the house of Parashram Lakkebaikar at Karanjali village in Khanapur taluk Thursday. Sources said Lakkebaikar was in the field when the incident happened. He returned to find the doors open and the house burgled. The burglars also broke into a closed house of Mhatru Lakkebaikar, who stays close to Parashram, but did not burglarise it. Nandagad police officers rushed to the spot with a sniffer dog squad, and have registered a case.

And whereas, now the Government after considering the report of the Competent Authority and satisfying itself about the urgent need to protect the interest of the depositors and in exercise of the powers conferred by sub-section (2) of interest of Depositors in Financial Establishment Act, 2004 (Karnataka Act 30 of 2005) hereby makes the following order, namely:

Now therefore, in exercise of the powers conferred by sub-section (2) of Section (3) of the Karnataka Protection of interest of Depositors in Financial Establishment Act, 2004 (Karnataka Act 30 of 2005), the Government under the circumstances stated above having satisfied that in order to protect the interest of depositors it is necessary to attach the movable and immovable properties believed to belong M/s Ishwarya Lakshmi Chits Pvt. Ltd., Bengaluru.
