How Bengaluru transformed from pensioners' paradise to India's IT capital

A sleepy little town at the south-eastern edge of Karnataka, known before the turn of the century as a Pensioner's Paradise, Bengaluru has rapidly transformed into the information technology (IT) capital of the country since the economic liberalisation of 1991.

In the past 35 years, few cities have attracted as much attention, mass migration for jobs, criticism over crumbling infrastructure, and yet a yearning to make it home. From 6.5 million according to the Census of 2001, Bengaluru's population shot up to 9.6 million. Though official Census figures are not available since then, estimates suggest the current population of the city might be over 12 million.

Bengaluru had all the ingredients to make it a big draw — cool weather with intermittent rain round the year, tree-lined boulevards, bustling pubs and bars in the central business district, and a low cost of living compared with the metros of that time. Indeed, old-timers vouch for not having ceiling fans in their homes.

"Bengaluru is the classic story of a cat-erpillar turning into a butterfly," says Harish Bijoor, a veteran brand and business strategy expert. "From a quiet little city where I would cycle without the risk of being knocked down to one which all of a sudden became slightly more dangerous because of the IT boom, I have seen it all."

What the city looks like now is a stark contrast: the weather has changed with often scorching summers that make air conditioners a must-have, small individual houses being replaced by high rises, huge portions of the city's greenery and lakes making way for swanky business parks and gated communities, very high cost of living, and depleting groundwater levels. A report by researchers at the Indian Institute of Science (IISc) shows a 79 per cent fall in the water spread area and 88 per cent loss of vegetation in Ben-

galuru in the past 50 years.

Despite these problems, people from across the country flock down to the southern city because jobs are in galore. Bengaluru, now known as the Silicon Valley and the startup capital, is home to thousands of global technology companies. With a thriving ecosystem of private engineering colleges across the state, the collaboration between the industry and academia has always been an advantage.

The city has always been the growth engine for the state. Bengaluru urban district contributed ₹11,73,574 crore, accounting for 40.4 per cent of the gross state domestic product (GDP) in 2024-25, up from 39.1 per cent, a year earlier, according to the state's Economic Survey. A substantial part of it is driven by IT services exports, which contribute almost 70 per cent, followed by industries and agriculture. The city's per capita income now stands at ₹8,55,960, significantly higher than the state average of ₹3,86,156 and the national average of ₹2,08,090.

This transformation is also visible in the state's changing development profile. According to the Karnataka Gazetteer of 1994, the 'real estate and business services' subsector accounted for just 5 per cent of the gross state domestic product in 1990-91. By 2025-26, it had grown to 41 per cent of GSDP, with the subset 'computer-related services' alone accounting for 32 per cent, per the state's Economic Survey.

Naresh Narasimhan, managing partner and principal architect of Venkataraman Associates, says Bengaluru already possessed the ingredients that many other Indian cities did not — a strong public sector and scientific ecosystem built around institutions like the IISc, Hindustan Aeronautics, Bharat Electricals, Indian Space Research Organization and numerous research laboratories. They created a culture of engineering, problem-solving and education long before IT arrived.

"What liberalisation did was remove the ceiling. It connected Bengaluru's intellectual capital to global markets. Suddenly, software exports became viable, multinational companies arrived, entrepreneurship flourished and an entirely new service economy emerged," he adds.

IT companies lead the charge

The boom in India's IT sector paved the way for Bengaluru to firmly position itself on the global map, largely helped by home-grown companies like Infosys and Wipro. While Texas Instruments opened

its first research and development (R&D) centre in Bengaluru in 1985 — laying the foundation for a journey that would help connect India's engineering talent with global innovation — mass migration started only in the mid-1990s.

Infosys' NR Narayana Murthy and Wipro's Azim Premji slowly started becoming household names as their firms started employing thousands of engineering graduates and gave rise to the white collar middle class that could afford their first car and house at an age the previous generation could not have dreamt of.

Ashok Soota, chairman and chief mentor of Happiest Minds Technologies, refers to an interesting aspect of that time when no one demanded domain knowledge. After 1991, US firms found India to be an ideal hub for back-end engineering work that could be done at a huge cost arbitrage helped by the large pool of engineers and their proficiency in English.

"The arbitrage benefit was so high that all that customers needed was scalable capacity, good processes and good governance. They taught us the rest," Soota says. He calls that the decade of large customer-led offshore development centres, where the IT sector witnessed heady growth rates

of 60 per cent plus per annum.

"Though it began as mainframe support, we were soon able to show that we could also handle client server solutions, product development and, as the internet evolved, projects which required quick turnaround times," he explains. A measure of its success, albeit negative, was when in the mid-2000s it briefly became a cautionary colloquial verb in some western countries, "Bangalored", which meant losing one's job to outsourcing.

Today, the city hosts some of the biggest technology and R&D centres of the most prominent firms globally — including Microsoft, Walmart, JP Morgan, Goldman Sachs, IBM, and Boeing. Bengaluru's tech ecosystem has got an added boost with the setting up of global capability centres (GCC). Almost 50 per cent of GCCs in India are based in the city, employing about 600,000 technology professionals in artificial intelligence, core engineering, finance and product ownership.

A change in landscape

The heady growth has altered the city's landscape and real estate. For decades, the traditional commercial areas included the famous MG Road, Brigade Road,

Commercial Street, Trinity Circle.

The IT boom shifted the centre of gravity eastward and south-eastward — towards Electronics City, Whitefield, Outer Ring Road and Sarjapur. Employment is no longer concentrated in one central business district. Bengaluru evolved into a polycentric city with multiple economic hubs with residential growth following employment.

As the city rapidly grew outward, the Karnataka government merged 110 villages into Bengaluru, officially enlarging the city's boundary. These areas became global business districts in less than two decades, but little of the planning required. The skyline changed dramatically, but public space did not keep pace.

"Great cities are not judged by the height of their buildings but by the quality of life between them. Early Bengaluru grew horizontally because land was abundant and mobility depended on roads. As land values increased and infrastructure investments concentrated in certain corridors, vertical development became inevitable," says Narasimhan.

In one respect the city has met the aspirations of its youth, it is now the pub capital of the country, with hundreds of establish-

ments dotted across micro markets. With a young working population, eating out in the restaurants — whose culinary spans across continents — has become the city's main source of leisure and entertainment.

Growth comes at a cost

The challenge, however, is that transport and civic infrastructure struggled to keep pace with the huge increase in population and its decentralised, often unplanned, growth. Experts and urban planners say in the next phase Bengaluru must strengthen these multiple centres rather than forcing everyone to travel across the city.

While the startup hubs of Indiranagar, Koramangala and HSR Layout look for the next innovative breakthrough in the world of technology, the city has become better known for its notorious traffic snarls — caused by narrow roads, limited public transport and mushrooming private vehicles. Unlike Delhi and Mumbai, cities like Bengaluru that have witnessed rapid urbanisation relatively recently — since the mid-90s — an established and well-oiled public transport system remains a distant dream.

Tara Krishnaswamy, senior consultant, outreach and partnerships at Indian School of Democracy, told *Business Standard* recently that Bengaluru's lack of public transport culture is down to its unique economic demographics.

"Bengaluru's growth always remained ahead of its infrastructure needs. Accordingly, for decades it has gotten a deservedly bad rap for its traffic jams, potholed roads, terrible pavements and so on. Some of it is just bad planning. The international airport took us about 10 years to complete. Why could the government not have built a metro connection from the word go?" asks Soota.

A tale of missing ownership

With such a humongous change since the start of the century, the city is virtually unrecognisable from what it was, much to the dismay of older residents.

Bijoor sums it up succinctly. He says that while previously waves of migrants came to Bengaluru to settle down, it started changing 30 years back. "There was an influx from everywhere who came to work and then went back to their own city. Everyone who lived in the city owned it, but since the 1990s, it has become a rented city. People buy houses and then rent it out to others. Ownership is the biggest element missing in the city."

The city must strive to rediscover its natural systems.

"Our valleys, lakes and storm-water networks should become public ecological infrastructure rather than engineering afterthoughts. Mobility will shift from moving vehicles to moving people. Bengaluru must retain what made it successful in the first place — its openness, diversity and capacity to attract talent from everywhere," says Narasimhan.
