Summary of amendments in MOA of the Company.

1.	<p>(a) Clause III (A) Main Object Clause, following para be inserted after sr. no.2 and be read as under:</p> <p>“3. To generate, transmit, and distribute electrical power from conventional and non-conventional sources; to undertake Engineering, Procurement, and Construction (EPC) contracts, consultancy, and allied services for public and private power projects. The Company may execute, operate, and maintain power generation, transmission, and distribution systems, and engage in trading, wheeling, storage, and distribution of electrical power. It may also import, export, assemble, install, and improve electrical appliances, energy devices, solar products, storage systems, and specialized electrical and electronic equipment for industrial, commercial, and domestic applications. To develop, own, operate, and maintain projects and infrastructure in power and renewable energy sectors, including solar, wind, hybrid, Battery Energy Storage Systems (BESS), Hydrogen, Compressed Bio Gas (CBG), Green Fuels, and other clean-energy technologies. The Company may participate in tariff-based competitive bidding (TBCB), tenders, and concession frameworks under BOO, BOOT, or similar models, either independently or through joint ventures, consortiums, or special purpose vehicles (SPVs), in India or abroad. It may also engage in research, development, and consultancy for renewable and sustainable energy, and undertake activities relating to infrastructure, technology deployment, and long-term operation, maintenance, and transfer of such projects.</p>
